December 2020 Emergency Coordinator's Report

Don't have anything to report for December, but I thought I do a quick recap of what happen in 2020.

At the beginning of 2020, we had just had finished off one of our busiest years in while. We had started to prep to help out with the Regional Convention when everything came to a screeching halt across the country. While prepping we started to make some updates to our communications trailer and continued after the restrictions were let up to the point where we could go downtown and do more work on it. We now are capable of running the MESH Network from the truck or trailer, the trailer has the permanent set up for MESH with a node mounted on the front of the trailer and an access point as well. We also hard wire our signal link into the trailer's computer and radio system.

Being that our real first real event of the year is the TMRA Hamfest each year and the virus hit days before it was schedule to happen and has kept pretty much everything else from happening.

All of our events, got cancel even the ones they thought they would be able to put on. We have been holding all of our meetings virtually and on the air since the pandemic started.

In May, we took the truck and trailer over to the marina district but due to the weather we didn't spread out like we originally planned. We discovered a lot of things that evening.

In June, our MESH Committee raided the Wood County Fair Grounds and had fun with their mesh equipment. They spread out all over the fair grounds and campgrounds. We learned a lot that day on how we can do with mesh that day and how much more we need to practice.

In October, we held our SET in which we only had a dozen participants involved. Mike W8MAL wrote the Incident Action Plan for our SET. We did it completely different this year, in the past they would send people out to the hospitals and key locations and check in, then just go through some frequency and modes. This year we treated as real emergency where operators were dispatched to assignments as they reported in. The Assistant Emergency Coordinators were assigned jobs at the beginning of the SET. Then the alert was set off alerting the rest of the members. Due to the pandemic a feel a lot of people did not volunteer this year.

That pretty much rounds up our year this year. I hope this next year will be better, we can get back to some what normal. I miss spending time with the best amateur radio operators in the world .

Shelby Co. ARES supported the Sidney / Shelby CO. Winter Wonderland REVERSE Parade of Lights. The parade was held at the Shelby Co. Fairgrounds. The Parade floats were stationary along the road inside the fairgrounds, while the public was allowed to drive thru the fairgrounds to see all of the parade entries with their Christmas lights and decorations. N8KZL KA8RVI, KC8CFI, KC6NLX, KE8LNS, KC8BUF, KD8RLF, N4QAD, KB8AXN, and KE8PYX supported the parade by placing all of the entries in the correct location along the route, then directing the traffic through the fairgrounds until complete. During the month of December, several SCARES members helped or assisted with the 1999 Ford F 550 that SCARES purchased in November. Several trips to businesses for a few repairs and to have equipment mounted. included N8KZL, KC8BUF, N4QAD, K8EEP, N8XM, KC6NLX, KD8RLF and KA8RVI each contributing time to help make this vehicle SCARES new tow vehicle. Still more work to do, in service plan is the end of January. We plan to offer the old SCARES tow vehicle to District 3, which is a 1985 Ford E 350 converted EMS vehicle from Ft. Loramie, Ohio. For December SCARES spent 152 total man-hours on this project. KC8CFI updated D-Star servers and SCARES repeater coordination's for an additional 3 man-hours.

SCARES monthly meeting and training for December, 2020, was not scheduled due to the Christmas Holidays. There were no Dayton Skywarn Nets activated for Shelby County for December. KC8CFI continued with SCARES calendar updates, and document updates, N8KZL, KA8RVI and KC6NLX spent time on phone calls, emails, quoting and ordering parts for an additional 18.5 man-hours.
