Ohio ARES Monthly Activity Report - August, 2022

Hi all. Good news and "encouragement!"

Of Ohio's 88 counties, we have only 10 that do not have EC's on the roster. That's a solid saturation of ARES in the state!

From these reports we can tally 1245 members, growing by 5 from June. 8 counties have single-digit numbers.

We logged 382 voice nets, 84 digital nets for a total of 1879 hours of participation.

We logged 516 meetings with 589 hours.

There were 60 public service events reported with 3617 hours and 45 emergency ops with 205 hours.

But that's not all the activity in the Section- the rest goes unnoticed and unreported because we don't see your monthly reports!

Of the July monthly reports from counties with EC's (77 potential) we received 43, which has become typical. Of those who did report, only 4 had no activity (no net, no training) to report, so the vast majority did *something*. For July we received NO reports at all from the entire District 2 (5 counties have EC's). Of the 10 DEC's for July we received 6 district reports.

I want to gently remind you that submitting a monthly report is a requirement, and it's not that difficult. If you are not able to do so, you can have AEC's assigned to the task to assist! It is a little more important that just crunching numbers. When the Legislature coughs up another attempt at hands-free driving, or deals with topics like antenna restriction we can produce these numbers to prove how amateur radio serves the community and deserves consideration while making these laws. It also helps us when working with EMA and other state agencies. It can even help you on the local level, as these overall numbers can improve your clout with your local agencies. It helps our stature with the League itself, and other Sections and organizations simply because of the size and therefore clout of our thoughts. So I'm asking you to keep the monthly reports coming!

Now- one more thing, and it's a contorted topic. That is activity itself. I am well aware that COVID killed economies and killed a lot of people. COVID sure took the steam out of amateur radio's community service as well – and it's been very slow to get it back. Of the 43 county reports, only 20 had public service activity and 14 reported emergency operations (presumably many were weather net related.) It's up to us – SEC, DEC, and especially EC – to encourage our members to participate and stay prepared. We just need to prod our folks back into operation. I don't have a cookie-cutter method to do that.

I have been in the volunteer fire service for 37 years or more, and I have found that the departments which run all the time, almost guarantee you won't sleep through the night and require tons of time and energy are actually the departments with the most people, the most enthusiasm and participation. Those departments who just don't get called much, whose trucks sit for days are another story. You'd think because there wasn't much 'drain' on the volunteers they'd be more willing to participate but the opposite is true. It's harder to recruit and much harder to keep their interest and enthusiasm... perhaps it's just because they're not getting used.

Like most volunteer organizations, this can be the case. So if we want to keep our people interested and be a draw for more, we need to stay active! Of course there won't be public service events every week for most of your counties. You can volunteer with neighbors who do have activities. And you can stage training events yourself that will help! Get outside, try different activities and work with your emergency agencies to participate in their exercises as well.

One big event in which we can ALL participate is the **Simulated Emergency Test (SET).** I emailed guidelines and general goals, but because of requests from all we have returned control of the exercises to YOU! With that comes the responsibility to actually create an exercise, get your people interested, and carry it out October 1. You need to be busy creating the format and MESL now to get everything ready in time!! I'm confident that your running a good exercise will have lasting results!
