National News (from ARRL and other sources)

The 13 Colonies Special Event will take place July 1-7, 2024. Operating times are July 1,1300 UTC to July 8, 0400 UTC. Thirteen special call signs will be on the air, each one representing one of the original 13 British colonies that were established in 1607. Three additional bonus call signs will be on the air representing Great Britain, France, and Philadelphia. All HF bands can be used, including the WARC bands, with the exception of 60 meters. Simplex on 2 meters and 6 meters is encouraged. The southeastern stations on the east coast are very close to each other. It will be harder for these states to contact each other so, use of 40-160 meters is encouraged. All modes of operation may be used, including SSB, CW, RTTY, and digital. The mode of operation is up to the individual colony state station. More information about logs, call signs, and QSL certifications can be found at The Annual 13 Colonies Special Event.

Starliner Docks to Space Station



NASA astronauts Butch Wilmore and Suni Williams, aboard Boeing's Starliner spacecraft, successfully docked at the International Space Station at 1:34 p.m. EDT on Thursday, June 6. As part of the agency's Commercial Crew Program, NASA's Boeing Crew Flight Test will help validate the transportation system, launch pad, rocket, spacecraft, in-orbit operations capabilities, and return to Earth with astronauts aboard as the agency prepares to certify Starliner for rotational missions to the space station.

Club Grant Program to Return

The <u>ARRL Foundation Club Grant Program</u> is returning for 2024. After receiving additional funding from Amateur Radio Digital Communications (ARDC), the next round of grants will be available later this year. More than \$500,000 in grants have been awarded to clubs across the country. This program centers around club projects that are transformational in nature (i.e., projects that have the greatest impact on the local community). Previously successful grants concentrated on the recruitment and training of new hams, STEM programs, emergency preparedness, and amateur radio technology development. ARRL Director of Development Kevin Beal, K8EAL, said, "ARRL is proud to partner with ARDC to administer the Club Grant Program. These grants offer an opportunity to have a significant impact on amateur radio's future."

More information will be announced on all ARRL news outlets in the coming weeks. Now is the time for your club to consider if you have a project that could qualify for a grant. Start thinking just how your club can impact amateur radio, today and in the future. Grants will be available for up to \$25,000 and will include reporting and media requirements. Stay tuned for additional information, and get ready for the next round of the Club Grant Program.

Friday Luncheon: "902 MHz EME Roving October 2023 - 27 States in 21 Days + WAS #1", by Peter Van Horne, K6AU

In September 2023, I decided to make a 902 MHz EME roving trip starting October 1, 2023. The goals included Al, W5LUA, completing WAS #1 on 902 and helping the other active 902 EME operators complete as many states as possible.

In this presentation, Tom will take you through his journey from HF DXing until he went on his first solo Gridpediton to EN67 in June 2023. Topics will include how he decided which grid to activate, the equipment and system used, how it turned out, and the lessons he learned.

Saturday Evening Banquet Keynote: "Sights Along the Way or Snorkel and Bounce" by Karen Orzech and Lance Collister, W7GJ

Lance and Karen will share their adventures in visiting exotic locations that Lance activated on 6 meter EME while Karen pursued photography and snorkeling hobbies.

You may wonder what happens at a Central States VHF Society Conference. The following paragraphs describe the highlights of a conference. When you attend, you can experience all of these functions. You also meet many people who enthusiastically embrace activating the higher bands. There are many propagation and communication modes to experience.

Two antenna ranges provide an opportunity for members to measure the gain performance of their antennas. In past years, new designs performed well. Sometimes, a quick adjustment provided improved performance. Antennas ranging from 144 MHz to 10 GHz can be

evaluated.

Low noise amplifiers extend range in weak signal environments. For many bands, amateur radio operators homebrew their own low noise amplifiers. The noise figure measurement bench provides an opportunity for the measurement of noise figure on a world class noise figure analyzer.

Since amateur radio operators rarely experience the show and tell of operational stations, many amateur radio operators bring rovers and microwave dishes to Central States VHF conferences to show other enthusiasts how simple or complex these stations can be. Weather permitting, we will be herded down the line of stations. Each owner then discusses the unique features of their stations.

Vendors display and sell their products in our vendor room. Some products are brand new. Some used. Some vendors salvage test equipment and commercial products to provide items that are useful in the VHF and higher bands.

Members share innovations, adventures, technological advancements, and operating practices in a series of presentations on Friday afternoon and all day Saturday. The hospitality suites provide an informal opportunity to interact with each other.

How to Plan and Apply for an ARRL Hamfest or Convention

If your amateur radio club is planning to host a convention, hamfest, tailgate, or swapfest, please consider applying for ARRL sanctioned status for your event. It is now an FCC requirement to have an FCC FRN; active email address and active phone number before taking any exam. Please bring your FCC FRN, original license, a copy of your license (if a licensed ham), a valid photo ID and \$15.00 - Cash preferred.

Effective April 19, 2022, the FCC will charge a \$35.00 application fee for amateur radio licenses. The fee will apply to new, renewal, rule waiver, and modification applications that request a new vanity call sign. License upgrades will not have a fee applied. The fee will be per application. VE's will not collect the fees at exam sessions.

<u>AE8FP Amateur Radio Test Team</u> administers ARRL-VEC testing in the Central Ohio area. Our test dates for 2024 are as follows: Januray 20, April 27, July 20, and October 19. Time and location for these dates are 10:00am at the Westerville Fire Station #111, 400 W. Main St in Westerville, Ohio. The listed dates are co-sponsored by the Central Ohio Radio Club (CORC).

The tests will start at **12 noon.** Please arrive a few minutes earlier.

To register, you will need a NCVEC 605 Form, which will be available at the test. If you would like to complete one ahead of time, be sure it is the Sept 2017 version or later. You can find it by Googling "NCVEC quick-form 605" and clicking on the url for a pdf of the form. Please note

the FCC requires you to provide a FRN (FCC Registration Number). Social Security Numbers are no longer accepted. If you are new to ham radio and don't have a FRN, Google "New FRN" and follow the fcc.gov link.

If you are currently licensed, be sure to **bring a copy of your license to the exam.** The cost of the exam itself is \$15.00, and if you wish to pay by check, it should be made out to the ARRL/VEC. Identification with your picture is also necessary, such as a driver's license. If you have any questions, please contact Scott Farnham, KO8O, at (440) 256-0320, or scottfarnham@roadrunner.com

In addition to the \$15 test fee, the FCC now charges \$35 to add you to the Amateur Radio database. The FCC will e-mail successful candidates instructions for payment directly to them. Payment must be made within 10 days of the e-mail. This charge does not apply to upgrades.



2nd Annual Northeast Ohio Amateur Radio Round Up



The **FT4GL DXpedition to Glorioso**, a solo operation by FH4VVK, Marek, is in its 2nd week, with well over 31,000 QSOs in the log. Originally, FT8 contacts were made using MSHV, but Fox/Hound mode is up and running as of

June 2 at 0000 UTC. The internet connection on the island is "very bad," so F8CRS is uploading logs to Club Log and handling verification requests. The following update is from W2IRT, Peter:

"Since the start of the FT4GL operation, all FT8 activities have been made using MSHV software since Marek was unable to get WSJT-X functioning for Fox/Hound mode. As of 00z on 02 June, the support personnel were successfully able to get WSJT working as it should, and Marek is now using Fox/Hound mode with that software. If WSJT fails again, FT8 activities will presumably resume in MSHV.

The Northern California DX Foundation (NCDXF)is pleased to announce its financial support of \$2,000 for the DXpedition by YL2GM, Juris, to **VK9LA**, **Lord Howe Island**, and **KH8**, **American Samoa**, in June and July 2024.

Ned, AA7A writes in his recommendation to the NCDXF board:

"One of the most prolific DXPeditioners today, Juris Petersons, YL2GM, has requested assistance from NCDXF to activate VK9L from 14 to 24 June 2024 and KH8 a few days later for another week.

The Foundation has supported Juris on at least 10 other DXpeditions that I can point to. These were either solo operations or teams he led conducting operations in 3C, 3C0, T30, C21, ZS8, S21, EP, 9U, ZD9, VU7 and quite possibly other places that I overlooked. His activation of ZD9 was nothing short of superhuman, in my opinion. So, wherever Juris goes with a radio, he can be counted upon to create quite a commotion on the bands.

While VK9L and KH8 sit at #61 and #72 on the global list on ClubLog's Most Wanted and #63 and #43 on the EU filtered list, an activation of these two entities by Juris and his traveling partner will create quite a lot of excitement."

Here is the latest update on the **CY9C St Paul Island** DXpedition: August 26 to September 5.

W0GJ, W0PR and WA4DAN had a very productive work session this week preparing for the CY9C DXpedition. We unboxed and tested all seven of the new Honda EU-2200i generators. We ran the generators with a substantial load and checked the voltage on each generator. All seven generators were right at specifications. We then inventoried and organized the guy ropes for the Spider Poles. We inventoried the low band antennas and hardware needed for those. Next, we inventoried all the bandpass filters. During the afternoon work session, we installed one of the new operating tents. This was exciting as we were very impressed with these new tents. We were so impressed; we will order a fourth tent for the DXpedition. We tested the new operating tables and chairs inside the tent for the optimum configuration.

The second workday was spent cleaning and working with the Yagi antennas. Each antenna was washed and thoroughly cleaned as these Yagi antennas were used on our CYOS DXpedition. During the afternoon session, we assembled and erected each antenna for testing. Each antenna exhibited a VSWR of under 1.5 to 1.

The CY9C team continues to seek financial support for the DXpedition. Contributions can be made on our website at: https://t-rexsoftware.com/cy9c

That's all for now.

73, Murray WA4DAN The DXpedition to **VP6DF**, **Pitcairn Island** is well underway. WJ2O, Dave, has been on 160-10M CW as VP6DF since May 30, and will continue through June 10. He reported "great runs" on 17M late last week. QSL via N2ZN and LoTW.

As a reminder, IV3FSG, Elvira, will be active as 5U5K from **Niger**, June 6-20. She will operate 160-6M SSB, FT8/FT4 using MSHV in multi-stream mode, RTTY, and maybe some CW. IKØXBX, Francesco, will be her pilot station. QSL direct to IK2DUW.

The band plan appears on the 5U5K QRZ page, and there will be an online log and a livestream. More information will follow as it becomes available.

We have another DXpedition to **KH8**, **American Samoa.** N5DD, Don; W5MJ, Madison; K5PI, Robert; and VE7KW, Keith, are heading to American Samoa (OC-045) to operate as KH8T September 2-16. They plan to have two stations on 80-10M CW, SSB, and FT8, and may also include 160 and 6M. They will have two linear amplifiers, hex beams, and verticals. QSL via MØURX. Their website contains more information, including their band plan.

F4FKT reports on his upcoming FT4YM operation from **Antarctica**, mid-October 2024 to March 2025. His station will be 100-300 watts to a multiband vertical on 20, 15, 17, 10 and "maybe" 12M, using SSB and FT8, FT4, and maybe the geostationary QO-100 satellite that covers Europe and Africa and apparently beyond. QSL direct to F4FKT or F5PFP, Club Log, or LoTW.

GØKOM, Adrian, has found a QTH to set up a station on the **U.K. Sovereign Base Areas in Cyprus, prefix ZC4**, "slightly inland but within the Sovereign Base Areas (KM64lq), where I can operate 24/7." He will be on as ZC4MK July 10-16, and leave on the 17th. He is figuring out his optimum antenna options, but knows for sure that on 6M, he will run 100W to a five-element Yagi.

WE have an update on **Bouvet 3Y0K.** The existing sailboat contract have been cancelled and there will be no January 2025 DX-pedition. We're now working on securing a large vessel and helicopter for the 3Y0K Bouvet DX-pedition anticipated for 2025/2026. We're currently negotiating those contracts and we will make an announcement for Bouvet when we're ready.

Along with Bouvet, here is an update on the **PETER I** 2027 DXpedition. Peter I is the #8 most wanted.

We plan to activate Peter I Island in February 2027 with a team of 19 operators. We have signed a financial agreement with a private group about sharing the cost for this DX-pedition. The DX-pedition budget and our share is around \$825,000, of which we must deposit \$340,000 in 2024.

We will go to Peter I with a large vessel and two helicopters, and the DX-pedition will be led by an external Expedition leader from an Antarctica Expedition company – Spirit of Sydney. The capacity of the Expedition leader and the vessel have been reviewed and approved by Norwegian Polar Institute and is the basis for the landing permit we received in April 2024. Our expedition leader has supported more than 80+ expeditions to Antarctica and has previously landed on Peter I three times. With the landing permit and external resources involved we're ready to move forward negotiating and signing the contracts.

\$2,000,000, including all logistics, marine, aviation, insurance, safety and rescue, and Antarctica permits. However, the synergies with the small private group and with the Spirit of Sydney Expedition Company have provided enough cost sharing to make this Peter I expedition affordable, albeit still expensive. This is a rare opportunity to activate Peter I and without these unique opportunities to share costs, Peter I would not be possible. At the time of activation in 2027 it will be 21 years since the last DX-pedition to this island, and cost is the primary reason. We have a unique occasion to bring Peter I back on the air. We're grateful for any donation that can help us sign the above contracts.

Despite it being almost 3 years until the DX-pedition time, the size of the deposit requires us to start fundraising now to be able to sign the vessel contracts.

If you want to donate and make this DX-pedition a success, please visit our website www.3y0.no one of a few weeks to one month to raise the funds needed to pay our first deposit of \$200,000, soon after signing the vessel contracts. DX-pedition planning will start by fall of 2025, but at this time we only raise funds to be able to pay the deposits required in 2024.

The following is from LA7GIA, Ken.

We're seeking more SSB/CW operators to **Peter I Island** DXpedition, dates are confirmed January 28th to February 26th, 2027.

We have received the landing permit from Norwegian Polar Institute and are currently negotiating the vessel contract. This DXpedition team will consist of 19 operators where we currently are 10 ops. We're now seeking additional 3-4 operators to this DX-pedition within short time. Please contact us at admin@3y0.no> This is an expensive DX-pedition with a high participation fee, duration 30 days + travel time.

KH0/KC0W, Tom has now been on **Saipan Island** in the Northern Mariana Islands for over five years and has managed close to 100K contacts. In the past several days he has "worked just over 325 stations on 6 meters". Tom's 6-meter equipment includes an Elecraft KX3, JUMA PA1000 running 800 Watts into a Hexbeam up 53 feet. He is in grid locator QK25ue. 6-meter openings that Tom has experienced "have been exclusively into Japan & China" with "booming signals on FT8" and not "very good luck on CW" as "no one there". He has had no luck into North America or Europe. He is "contemplating on purchasing a

large 50-foot boomed 6-meter Yagi since [he has] enough room for it on the roof of [his] condo".

JY4CH, Haitham, is in Amman, the capital of **Jordan**. He is running an IC-7200 into a Hi-Gain TH5 tri-bander (10, 15 and 20 meters). He is running 70 watts. On 6 meters he can use the TH5 with a VSWR of 1.3. Haitham is in grid locator KM71wx.

The latest episode of The DX Mentor, number 43, NE8Z (HD8MD), Rick, has been posted and is now available wherever you get your podcasts.

their good and bad days, it appears activity might be down a bit. So let's put the blame on those normal Summer activities.

One amateur activity catching the attention of a number of hams started on June 1 and runs daily



through the 16th. It is the annual 16 day Lewis and Clark Trail On The Air operating event. Washington's **Clark County ARA** has put together a network of clubs along the Trail to represent the Trail passing through their state. The event is similar to the popular "13 Colonies" and "Route 66" events. Speaking of Field Day, many clubs are actively planning their operation. All Things ARA will operate from the Alley Park, Old Logan Road, in Lancaster. The Athens County ARA returns to the Athens County Fairgrounds. The **Cambridge ARA** will operate from the Grove Park north of New Concord. Last years site was a good one for the **Clinton County ARA** causing K8GO's return to the 1020 Farmer's Road, Wilmington location. Print an Official or Unofficial Copy of Your Amateur Radio License

As of February 17, 2015, the **FCC no longer routinely issues paper license documents** to Amateur Radio applicants and licensees. The **35** | P a g e



Commission has maintained for some time now that the official Amateur Radio license authorization is the electronic record that exists in its Universal Licensing System (ULS). The FCC will continue to provide paper license documents to all licensees who notify the Commission that they prefer to receive one.

Licensees also will be able to print out an official authorization — as well as an unofficial "reference copy" — from the ULS License Manager. I've created a set of instructions on how you can request an "official" printed copy of your license*
