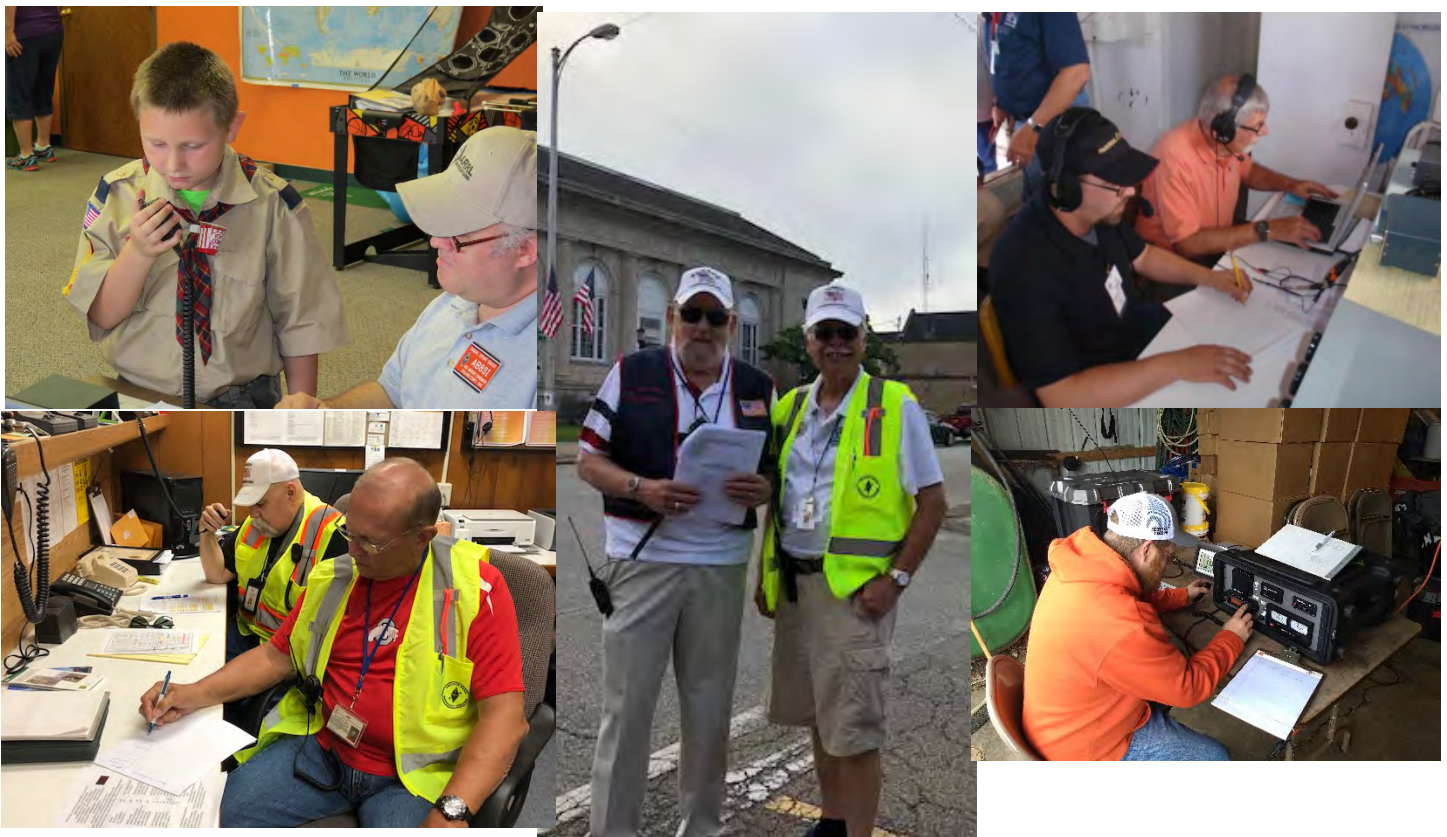

**ARRL Comments in “Strong Opposition” to Part 15 Modification Petition Affecting 5 GHz**

ARRL has [commented](#) in “strong opposition” to a [Petition for Rulemaking](#) by RADWIN Ltd. that seeks to amend certain Part 15 rules to permit point-to-multipoint (P2MP) communication services in portions of the 5 GHz band, at power levels now permitted only for point-to-point unlicensed systems. ARRL has focused its concern on proposed high-power P2MP operation in the band 5.725 – 5.850 GHz, but points out that the entire 5.650 – 5.925 GHz allocation has been “subjected to a continuing series of overlays domestically” for more than 2 decades. Amateur Radio is secondary to military radars on the band.



ARRL said the Amateur Radio national “weak-signal” calling frequency of 5.760.1 GHz already has experienced a “very substantial” rise in ambient noise in many areas that has significantly affected Amateur Radio operation in the 200 kHz centered on that frequency, where extremely weak received signal levels are typical. Only low-density usage and the low-power levels permitted for unlicensed national information infrastructure (U-NII) devices have sustained “a good deal of compatibility” between Amateur Radio and U-NII devices at 5 GHz, ARRL said.

“It is quite obvious that RADWIN’s proposal for simultaneous point-to-multipoint transmission, with higher input power and [effective isotropic radiated power (EIRP)], using an electronic steerable antenna system, presents an exceptionally high interference potential to ongoing, weak-signal Amateur Radio Service communications,” ARRL said in its comments filed on July 30. With users located “at all points of the compass from the distribution point,” ARRL said, the potential for interference to Amateur Radio “is *much* greater.” Greater yet, ARRL noted, is the potential of interference to users of RADWIN’s system.

ARRL said the FCC “has no idea at all” about aggregate noise levels in the 5 GHz band in general, while Amateur Radio and Amateur Satellite users have reported increased ambient noise levels in the band, especially near 5.760 GHz. “Both the *Petition* and the technical statement accompanying the *Petition* are silent on potential interaction between P2MP simultaneous transmission systems operating at high power, and any Amateur Radio facility,” ARRL said. “As a result, the petition is fatally flawed and should be dismissed, relative to the 5.725 – 5.850 GHz band.”

ARRL asserted that the FCC lacks jurisdiction to authorize Part 15 device operation by rule, “absent a specific finding that the device will not predictably cause interference.” Unlicensed, very low-power Part 15 devices may not cause interference to licensed services and must accept any interference caused by a licensed station and must shut down if notified by the FCC that the device is causing harmful interference.

ARRL said RADWIN’s *Petition* not only is flawed but fails to address the issue of compatibility between the proposed high-power P2MP Part 15 operation and individual stations in incumbent primary and secondary services. “It is long past time that petitioners such as RADWIN provide in their rulemaking petitions dealing with Part 15 rules enough data to allow the Commission to make an evaluation that fulfills its obligation under the Communications Act,” ARRL concluded. “RADWIN’s *Petition* must be dismissed as one which fails to provide an adequate justification for the relief requested.”

## *New law adds \$100 fine for distracted driving*

As reported in a story in the Cleveland Plain Dealer recently, Ohioans could face a fine of \$100 for Distracted Driving when the changes take place the first of October. Governor Kasich signed into law some new regulations on our current Distracted Driving Law that could get you fines of up to \$100.

Some of you have sent me emails about this article, and if these new changes will apply to Amateur Radio operators while driving. As it is written, it does not effect the use of a two-way radio. Bob Winston, W2THU, our State Government Liaison wrote about this in his article that appear in the June edition of the Ohio Section Journal <http://arrl-ohio.org/news/2018/OSJ-Jun-18.pdf>

**Texting while driving** has been a secondary offense in Ohio since 2012. But House Bill 95, which passed the legislature with bipartisan support, applies to distracted driving in all its forms. Similar laws are already on the books in Connecticut, Maine, Washington state, West Virginia and the District of Columbia, according to the American Automobile Association.

As it was reported in the Cleveland Plain Dealer, no one testified against the distracted-driving ban. But some questioned how enforceable the measure would be, and others argued the measure should go further and allow cops to pull over motorists just for distracted driving.

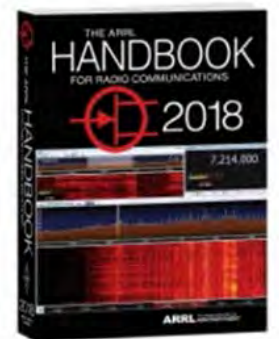

This experiment, currently scheduled for three years, will make 6,600 online courses available to those card holders. Of special interest to ARES members may be the hundreds and hundreds of computer courses. Programming languages, IT subjects, computer aided design and many other topics are available now for a monthly fee, but in September the Ohio public library network will begin to cover all costs.

Here's your chance to be the Hunted and not the Hunter.

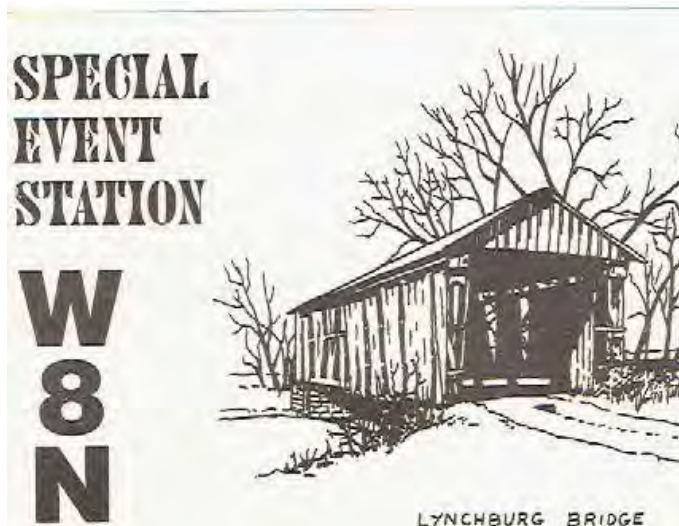
Why you should operate:

We are in need of many volunteers for the Hopkins Airport drill on **Friday, September 14**. We will need at least approximately **25** people to staff this event. Unfortunately, it does take place on a Friday, so we anticipate having extreme difficulty filling these roles. If you are available, **PLEASE** plan to attend and sign up at the link below as soon as possible so we can plan accordingly.



Additionally: Because of the nature of the drill we are going to try to implement **FLDIGI**. It's entirely possible this may be an epic failure, but we've been talking about how helpful it would be for years, so the time to at least try it is NOW. Because of this, the July meeting (July 22 in Independence) will be focused on FLDIGI. If you have the ability to operate FLDIGI or want to learn how, please come. We are going to dedicate the entire meeting to getting FLDIGI set up and practiced with anticipation of being prepared to use it in September.

Please plan to bring your radio, computer, Signalink (if that's what you use), and any cables needed to connect the radio to the computer. Because of the nature of the drill, we will **NOT** be doing any acoustic coupling. You **MUST** be able to plug your radio physically into your computer. If you aren't able to do FLDIGI that's OK. We still need your help with the drill.

This will not be an all or nothing scenario. Stations able to pass digital traffic will be able to, but those with only voice capability will also be able to pass the traffic that way. Net control will not be sending info out via digital so no one without digital capability will miss anything. Net Control will simply be "able to accept" digital traffic from those who can send it.

You absolutely will need to complete all **7** of these courses to get your ICS 300/400 credit. Here are the courses that you need to take: **IS-120, 230, 240, 241, 242, 244 & 288.**

4. The understanding that specific agency agreements and needs must be honored.
5. Mutual aid pacts may require training specific to adjacent jurisdictions.
6. If you have a concern about a new policy, be prepared to offer an alternate.

**IS-120, 230, 240, 241, 242, 244 & 288.**

Let’s not forget that it is going to be a very important part of what we do **from now on!** We want no one left behind, or not credited for the courses that you have taken. Now, don’t forget that your ICS certificates aren’t the only things we’re looking for either. If you have Basic or Advanced First Aid, CPR or AED training, it’s also very valuable in the field as well. And, don’t forget about the newest training out there, “**Stop the Bleed...**” This one is really good, and it’s something that you can use no matter where you are. These courses are not only useful for you in the field, but you’d be surprised how they can help you around the house as well. Remember, most accidents happen within 25 miles of you home! And YES, my accident last year happened within that 25-mile radius. You need to be prepared!

Here’s the figures as Jim, W8ERW has given them to me... Members in the database – **970**; Active members – **936**; Members NIMS complete -**724**; Total courses logged - **6,816**. These numbers just keep growing. And we want them to continue for sure!

Now, did you notice? We are just **1** away from sending out an ARES Mesh Vest to that **725<sup>th</sup> person!!!!** Will it be you? I’ve been absolutely surprised that we’ve gone an entire week without getting the 725<sup>th</sup> person. If you haven’t sent yours in yet, this would be the perfect time to do that.
