## **Social Security update**

The following is from the Kim Komando newsletter – I've copied it here because many of you may have received this email and wondered if it was legit.

# Surprisingly, it's not a scam

My inbox is flooded with folks asking about an email they got from the Social Security Administration. I mentioned it earlier this week, and, nope, it's not a scam — it's legit. But this change is big enough that we need to spend more time talking about it.



## Social Security scoop

The new home for all things Social Security online is <u>Login.gov</u>. The idea was to make signing in easier, but they also needed to comply with federal authentication standards.

Even if you don't collect welfare checks or SSA retirement benefits, it's worth updating your account. This way, it's easy to order a replacement Social Security card, estimate your future retirement benefits, and say what benefits you want and when. If you already have a Login.gov or **ID.me** account, you're good to go.

If you registered for a my Social Security online account before Sept. 18, 2021, do this:

- Go to **SSA.gov** and sign in with your existing credentials. You'll be prompted to change over to Login.gov.
- Follow the on-screen instructions to create a Login.gov account. At the end, you'll receive a confirmation screen.
- Log in and access your account. That's it!

#### Club activities

I've noticed an interesting thing happening – Ham Radio clubs are becoming more active! A lot of that activity revolves around activities and events, and that's a good thing. Anytime you can get Hams together for something where they will have FUN with their hobby, they'll want to do more of that. And I also notice that those activities often times are "multi-club" activities where two or more clubs get together for the planning and implementation of the event. These events include POTA activations, Fox-hunting, antenna builds and most include food! Get the clubs in your area activated in some of these events. Truly a fantastic idea for those of you putting on these events! As more of these things come up, we're bound to have some date/time conflicts – and we already have. But that's OK. It's good to have choices.

I've also noted some very good ideas lately to help new hams get started. The attrition rate in Ham Radio is very high in the first 6 months. We need to get new hams on the air and engaged with the hobby as soon as they get their license. The longer it takes them to get engaged, the less likely they ever will. Please, listen for them on your repeaters and call back to them. Before they leave your test session make sure they have an idea of what repeaters they might have the best luck hitting with an HT. Let them know when your nets are. Make sure you get their phone number / email address and make contact with them in the first week after they test to help them get started. This is critical to keeping them in the hobby!

# America's Rocket is on the Move



On Tuesday, July 16, the first core stage of NASA's Space Launch System rocket for the agency's Artemis II mission began a journey from the Michoud Assembly

Facility in New Orleans. The core stage was moved onto the agency's Pegasus barge, where it will be ferried 900 miles to Kennedy Space Center in Florida. Once at Kennedy, engineers will prepare it in the Vehicle Assembly Building for attachment to other rocket and Orion spacecraft elements.

- Working on getting my General license Advancing my knowledge and capabilities in ham radio by aiming for my General license. This will not only enhance my personal expertise but also enable me to bring more advanced concepts to my students.
- I'm excited to bring this hands-on knowledge and experience back to my students. Integrating these skills into my curriculum will provide them with a deeper understanding of electronics and inspire them to pursue their own STEM passions.

# **ARRL Student Membership**

ARRL Student Membership was established to increase youth participation and long-term involvement in amateur radio. Student members can access ARRL membership benefits including the digital versions of ARRL magazines, and the extensive courses and training materials available through the ARRL Learning Center.

Please note: ARRL requires age verification for all student members. Parental/Guardian consent is required for applicants under 18 years of age. Student memberships are not eligible for add-on printed membership magazine subscriptions. Student membership benefits are subject to other estrictions and exclusions.

Student Membership options:

- Option 1: **Full Student Membership.** Dues rate \$30 per year. This low-cost membership option is available to US Amateur Radio licensees under the age of 26 years. Applicant must be a resident of the US, its possessions, or Puerto Rico. A full member may vote in ARRL elections for Division Director, Vice Director, and Section Manager. Other restrictions and exclusions may apply.
- Option 2: Free Student Membership. This no-cost, Associate membership option is available to full-time students aged 21 years or younger. Applicant must be a resident of the US, its possessions, or Puerto Rico. Free Student Membership excludes access to the ARRL E-mail Forwarding Service, and Associate members may not vote in ARRL elections. Other restrictions and exclusions may apply.

#### The following information is for ALL exam sessions:

It is now an FCC requirement to have an FCC FRN; active email address and active phone number before taking any exam. Please bring your FCC FRN, original license, a copy of your license (if a licensed ham), a valid photo ID and \$15.00 - Cash preferred.

Effective April 19, 2022, the FCC will charge a \$35.00 application fee for amateur radio licenses. The fee will apply to new, renewal, rule waiver, and modification applications that request a new vanity call sign. License upgrades will not have a fee applied. The fee will be per application. *VE's* will not collect the fees at exam sessions.

AE8FP Amateur Radio Test Team administers ARRL-VEC testing in the Central Ohio area. Our test dates for 2024 are as follows: Januray 20, April 27, July 20, and October 19. Time and location for these dates are 10:00am at the Westerville Fire Station #111, 400 W. Main St in Westerville, Ohio. The listed dates are co-sponsored by the Central Ohio Radio Club (CORC).

The next meeting (Feb 15) will cover the same topic. Bring your laptop!





It is 1.7 miles south of I-90 on Route 306 (Chillicothe Rd). The library is on the left, just beyond the Marathon gas station. The tests will start at **12 noon.** Please arrive a few minutes earlier.

To register, you will need a NCVEC 605 Form, which will be available at the test. If you would like to complete one ahead of time, be sure it is the Sept 2017 version or later. You can find it by Googling "NCVEC quick-form 605" and clicking on the url for a pdf of the form. Please note **the FCC requires you to provide a FRN** (FCC Registration Number). Social Security Numbers are no longer accepted. If you are new to ham radio and don't have a FRN, Google "New FRN" and follow the fcc.gov link.

If you are currently licensed, be sure to **bring a copy of your license to the exam.** The cost of the exam itself is \$15.00, and if you wish to pay by check, it should be made out to the ARRL/VEC. Identification with your picture is also necessary, such as a driver's license. If you have any questions, please contact Scott Farnham, KO8O, at (440) 256-0320, or scottfarnham@roadrunner.com

**In addition** to the \$15 test fee, the FCC now charges \$35 to add you to the Amateur Radio database. The FCC will e-mail successful candidates instructions for payment directly to them. Payment must be made within 10 days of the e-mail. This charge does not apply to upgrades.

The Club was initially organized in 1974 as the Communications Group for the Bellbrook-Sugarcreek Township Disaster Plan and was officially founded on July 4, 1976 with twenty "charter members."

BARC acquired space in a former elementary school in 2007 for its Clubhouse which includes a Communications Center with four well-equipped stations providing voice, morse code capability and digital modes on all amateur bands.

BARC jointly sponsors Spring and Fall license courses with the other two Greene County amateur radio clubs and Greene County Amateur Radio Emergency Service (ARES). BARC also provides ongoing continuing education opportunities, study groups and special interest groups on antennas, digital communications, Morse Code and operating skills, and other topics of interest.

BARC's big annual activity is Field Day in which it has participated since 1976. The Club has an annual Field Day Family Picnic, an annual Dinner Meeting, an annual Chili Supper and a weekly "Lunch Bunch." One of BARC's mottos is, "FUN, FOOD & FELLOWSHIP." The Bellbrook Amateur Radio Club is a friendly group of hams of all ages that doesn't know any better than to just have fun while promoting and enjoying amateur radio and being ever ready to respond as needed when disaster or a communications emergency occurs.

This revision was done to encourage hunters to use their triangulation skills to read the fox simplex transmissions

And not rely upon "clues" to solve the location question.

KC8JRV Kirk Groeneveld of Athens, Ohio will be the next fox, with a tentative date of August 10<sup>th</sup> in mind. The hunt is open to any Ham with a two meter rig

(or HT) that can monitor 147.495 for transmissions and clues, and a directional antenna. Pre-registration starts at 9:45 a.m. and the hunt starts at 10 a.m. The HVARC Club repeater of 146.345 Mhz is used for registration and any clarification or two way communication needed during the hunt.

**SUMMIT COUNTY, OHIO**—County Executive Ilene Shapiro and her Emergency Management team recently partnered with Summit County Amateur Radio Emergency Service (ARES) to enhance the volunteer organization's capabilities to assist in an emergency response. The County is now hosting ARES equipment on its radio tower at Summit Emergency Communications Center, ensuring reliable communication throughout the county and with state partners in the event of an emergency.

ARES is comprised of licensed amateurs radio operators who voluntarily register their qualifications and equipment for communications duty in the public service if a disaster strikes. Members are required to meet certain national standards, including completing Federal Emergency Management Agency and National Weather Service training. The group has 60 volunteers dedicated to supporting their community and many also serve as volunteers with the Twinsburg, Copley and Summit County Community Emergency Response Teams (CERT).

"Summit County is proud to support ARES and its dedicated volunteers. When disaster strikes, we need all hands on deck to respond," said County Executive Ilene Shapiro. "By providing access to our radio tower, we are better prepared for emergencies and will have stronger communication capabilities should an event occur."

Summit County EMA and ARES have a long history of collaboration. ARES has provided backup communication for the County's Emergency Operations Center (EOC) in both actual incidents and training exercises, helping to coordinate high-quality emergency response efforts and increasing preparedness and response capabilities. ARES also provides support to the American Red Cross, Akron Marathon and other local public service events. And as trained SYKWARN spotters, ARES members help monitor and report severe weather conditions. The group's participation in yearly SKYWARN training ensures they are prepared for weather-related information during emergencies.

"ARES appreciates Summit County's support and the strong collaborative relationship we have maintained for many years. Our volunteer members are committed to supporting our local public safety forces in the event of an emergency or disaster. Working together, we are keeping our community safe," said ARES Emergency Coordinator Ken Dorsey.

The Dateline DX Association (DDXA), a worldwide DX organization, is pleased to announce to the amateur radio DX community that it will operate from the small island nation of **Sao Tome and Principe**, **S9Z**, from November 11-20. The license, issued by the General Regulatory Authority (AGER) in Sao Tome and Principe, authorized the call sign S9Z. This operation will be on CW, SSB, and digital using hex beams and tall verticals on 160-6M, as well as 432 MHz EME. The S9Z team includes N4XP, Tom (leader); 5B4AQN, Roman; CT1BOL, Jorge; Jose' CT1EEB, José; HI8RD, Rigo; I8NHJ, Max; KH7U, Kimo; KJ7KOJ, Angus; KØIR, Ralph; K3VN, Al; N2WB, Bill; N6MZ, Mike; WB4JTT, Dave; and W7YED, Robin. All are highly experienced in DXing, DXPeditioning, and contesting. The S9Z website is under construction; in the meantime, information is being posted on QRZ.com.

W7GJ, Lance, plans to mount a six-meter EME DXpedition from **Tristan da Cunha**, September 26 - October 25, with the callsign **ZD9GJ**. He is currently on waiting lists for sea passage leaving Cape Town, South Africa on September 18,

and returning on October 27. None of this is a sure thing, however; he says that may be "bumped" for higher-priority passengers. "All my equipment is checked, packed and sitting here ready to go with me on the next DXpedition – I just need a confirmation of passage." In the meantime, Lance is investigating the possibility of activating another rare DXCC entity for the first time on 6M EME in case the ZD9 trip is canceled again. "I was hoping that ZD8 [Ascension Island] could be a backup location, but research has shown that there currently is no place to operate and only friends and relatives of those already living on the island are issued visas. I am still investigating the possibility of H4Ø [Temotu Province] and D6 [Comoros], but neither of those DXCC [entities] currently have good lines of communications, so it is taking longer to move forward on those. In the meantime, fingers are still crossed for ZD9!" Lance will post updates on his website.

K8R testing continues apace. Per AA7JV, George, on July 12, **K8R** is now on the air in American Samoa, testing equipment, antennas and the new SuperFox mode ahead of the "real thing" in August – the historic trip to Jarvis Island as N5J. "This is our last chance to get everything right," says George. "A RIB DXpedition is different than a traditional one where you can fix and move things around on the fly. With us, once equipment is on the island, it is very hard to change things or fix what is not working. Our plan is to get every station and antenna working here and put it all back on the RIB boat as is, hoisted it up onto [the ship] Magnet, ready to be launched at Jarvis." Continues George, "The K8R test setup is on a narrow beach on the north side of Tutuila Island, the main island of American Samoa. The beach is a private beach where the owner was gracious enough to allow us to set up and operate. This is an ideal location for a small DXpedition from a remote but still easily-reached place. Takeoff to the north is over water. But for us, the beach is too small, as eventually we plan to have seven stations and eight antennas. K8R has now four stations operational; one local and three remote-controlled. Because the beach is small, our antennas are close to each other, but so far, our filters seem to be working. Heavy rains have hampered the effort, but they are on the air as much as they are able."

We have an update from yesterday: The K8R team has now spent 6 days configuring the Jarvis equipment on American Samoa and testing the stations.

We expect to be QRV another 5 days or so. One of the important tests has been the first DXpedition use of SuperFox. In almost 6 days we have logged 16,000 SF QSOs. We have two stations configured for WSJT-X RC5.

While most of the Hounds have had no trouble working us in the new mode, there have been some interesting items that have popped up on Hound's ability to consistently decode our signals. This has not been universal, but some have yet to make a QSO. Fixing these will require a new release from the Development team. They are not critical flaws, but we do not want to deprive anyone of a K8R QSO so effective Thursday UTC 00:00 our 20 M Super Fox dedicated station will remain operating Superfox while the second digital station will be on normal Fox/Hound.

When the new release is issued and properly tested, we will revert to all SuperFox.

The decision of which version(s) to operate from Jarvis will be made after all testing is done. Remember, K8R was a test operation. We appreciate all the callers to help us and the WSJT team evaluate this new mode. We expect to be QRV another 5 days or so. We depart for Jarvis on August 1.

We have an update on the **3Y0K Bouvet** DXpedition. We're still negotiating the contracts for a DX-pedition to Bouvet Island. This DX-pedition will be a large scale operation with 20-24 operators and we are searching for 4-6 more CW/SSB operators to complete the team www.3y0k.com <a href="http://www.3y0k.com/">http://www.3y0k.com/</a>>.

We are looking into several options how to execute the expedition, where the focus right now is the logistics of the helicopters. In late June, we received the helicopter permit from Norwegian Polar Institute, and thus have all permits we need to activate Bouvetøya. The helicopter permit allows us to setup camp on either the SE or the SW side of the island. In 1927, the first Norvegia expedition

landed on Bouvetøya, and claimed it for Norway. They also landed on "Larsøya" a small rocky island at the SW part of Bouvetøya. Our landing permit extend from the plateau above this SW corner all the way to the SE part at Cape Fie. 99 years after the Norvegia expedition we plan to land on Bouvetøya with helicopters. Our permit is valid for a helicopter operation in the period November 2025 to March 2026.

IZ5WPZ, Antonio, was on the air July 10-15 from Iraq as YI9WP.

**VK9/C - Cocos (Keeling) Islands -** The VK9CV expedition is November 1-15. While there they plan to upload the log to Club Log once a day, and they will not have livestream. They plan to be active on six meters.

**5R** – **Madagascar** - M0KRI, Shabu, is planning to be QRV from Nosy Faly (AF-057), Madagascar as 5R8SR. The exact dates have not been decided but tentatively he is looking at going in mid-September 2024. He'll have an IC-7300 and IC-706 running 100 watts to a vertical. Activity will be on CW, FT8 and SSB on 80 through 6 meters. QSLs will be uploaded to Club Log and LoTW. QSL only via OQRS on Club Log.

Here is an update on the DXpedition to **Vanuatu**. DX Engineering has become a Major Sponsor for the October 2024 Vanuatu DXpedition. With their help there will be two stations on the air from October 16-30, 2024. Priority for the DXpedition will be the 2024 CQ WW SSB Contest on October 26-27. We will be operating High Power multi-multi.

Vanuatu is an island nation between Fiji and Australia and accessible by commercial airlines. Plans for the DXpedition are being handled by Van Herridge, N4VGE/YJ0VV, who has made reservations at a luxury villa, Asana, just outside of Vanuatu's capital only 100m from the beach.

Currently there are three hams committed to going: John Schroeder, K4QQG; Nick Maslon, K1NZ / YJ0NZ; and myself. The DXpedition is from October 16 - 30, 2024 and there is enough room in a luxury villa for two additional hams and their XYLs or OM. Those not operating the radios will find a safe and hospitable, pacific paradise. There will be several contests during the DXpedition including the CQ World-Wide SSB Contest. Timing will allow us to take advantage of the excellent Southern Hemisphere springtime propagation on top of the best sunspot activity in years. Equipment includes a Flex 6700, Icom 7300, and a Yaesu 891 for several POTA activations. Matched to these will be an Acom 1200s and ETO 91B legal limit amplifiers. Antennas will include a 6-20m hex beam, 10-160 inverted V fed by ladder line, an end fed 160m long wire, multi-band vertical, vertical arrays, bazooka long wire, DX Commander Expedition (for POTA) and additional antennas.

In addition to operating as a DX station we will have the opportunity to operate at several POTA and IOTA locations. If interested contact Van, N4VGE / YJ0VV, as soon as possible.

We leave in three months. Will you be with us?

This is a Laurel VE session and there is no charge to take a test; however successful first-time candidates are still subject to the FCC fee for a first license. Then on Sunday, September 1 the **Athens County ARA** will hold a license testing session during their Trunkfest at the Athens Masonic Lodge in Athens. The Trunkfest is a free event and will run from 8 until noon. However there is a fee to take a test. Walk-ins are welcome.

On Sunday, August 4 the **Cambridge ARA**'s Waller-McMunn Radio Museum will be open to the public. The Museum honors the establishment of radio station WEBE in 1924 that served the Cambridge/Guernsey County area until it was removed to Zanesville and later became WHIZ in 1929.

I recently noted the passing of Jerry Becker, WA8R, of Leesburg. On August 24 there will be a Celebration of Life at the Leesburg Fire Hall from 1 to 5. Jerry was known throughout the region for his ability to fix almost anything electronic. He had been a technician for Yaesu at their old Cincinnati repair facility.

**Athens County ARA** President Eric McFaddin, WD8RIF, reminds ACARA members the Club does not hold in-person meetings during July, August and September. October 17 should be their next meeting.

Although July hamfests in this part of the state are slim pickins and require some travel to find one, we're excited to learn that the out look for August gives us at least one we can attend amost every weekend.
