Continuing on last week's message regarding representing Amateur Radio to the public – the QR code here will take you directly to the ARRL brochure "Why You Should Give Amateur Radio A Try". You can find it on the ARRL website in the "ARRL STORE" under the Exhibit Supplies tab. This is available for FREE!

I can immediately think of two ways to use this: Do you have an Amateur Radio business card? You probably should. When someone asks about your hobby,

what you're doing at a POTA activation, what's the antenna on your car for.... You should be ready to give them the 1 to 2 minute "elevator" talk about what Amateur Radio is. Follow that up by giving them your card with this QR code on the reverse side. They can now get some further information from ARRL plus they can get ahold of you if they think it's interesting and would like to know more. Too often we talk to someone who has shown an interest in what we are doing, tell them how Great it is, and then send them away without any easy and convenient way to find out more about us. Don't Do That!

If you are out at a group or club activation of any kind, you should have the printed brochure ready to give away to any interested passersby. Along with it, or attached to it, you should have additional information regarding your local Club, ARES Unit, or any other "Group" that they may want to contact for more information or to get involved with. I won't say that "people are lazy", BUT, they do like to take the easy way out, and the easier we can make it for them to find out more about the hobby, the easier it will be for us to convert them to members of the hobby!

Did you know that the ARRL makes a "First Contact" award available? Everyone makes a first contact, and that contact often times will set the course for a new hams experience with the hobby! If YOU make a contact with someone who informs you that this is his/her *FIRST* QSO, then anything you can do to make it special will help to keep that new ham an active and engaged ham. (The opposite of an unimpressed and uninterested / unmotivated ham who will soon become an "inactive" ham). After you've made their first contact a memorable one, how about commemorating it with a certificate? It's available on the ARRL website as a fillable .pdf file which you can present to the new ham.

If it's a local new ham, get him to your club meeting and make the presentation there, which will immediately introduce them to the other club members and let them know that they are now a

Part of Something, not just another person with a callsign lost in the crowd! If you can't get them to the meeting, print it out and mail it to them (please put it in an envelope big enough so you don't have to fold it up).

Maybe you're a relatively new ham, and someone really went out of their way to help you along in getting your license, and then really "becoming" a Ham! That person would certainly be surprised and impressed to receive the "Mentor Award" from you! Again, especially appreciated if presented at their local club meeting.

Next up I want to talk about the "Rag Chewers' Club". It's pretty simple. You are required to have a 30-minute QSO with another station. The other station issues you the certificate, which is available as a PDF on the ARRL website:

You can fill in the certificate and either mail, email, or hand it to the station you are issuing it to in person. It can be for any class license (Tech / General / Extra) for a QSO on any authorized band for the recipient (no, a cell-phone call doesn't count).

Making new hams is critical to our future, but just getting someone licensed is not enough. We need to get them engaged and active. We nee to build that sense of "community" and that we are something you really want to be a part of!

### NASA Decides to Bring Starliner Spacecraft Back to Earth Without Crew

NASA will return Boeing's Starliner to Earth without astronauts <u>Butch Wilmore</u> and <u>Suni Williams</u> aboard the spacecraft, the agency announced Saturday. The uncrewed return allows NASA and Boeing to continue gathering testing data on Starliner during its upcoming flight home, while also not accepting more risk than necessary for its crew.

Wilmore and Williams, who flew to the International Space Station in June aboard NASA's Boeing Crew Flight Test, have been busy supporting station research, maintenance, and Starliner system testing and data analysis, among other activities.

"Spaceflight is risky, even at its safest and most routine. A test flight, by nature, is neither safe, nor routine. The decision to keep Butch and Suni aboard the International Space Station and bring Boeing's Starliner home uncrewed is the result of our commitment to safety: our core value and our North Star," said NASA Administrator Bill Nelson. "I'm grateful to both the NASA and Boeing teams for all their incredible and detailed work."

Wilmore and Williams will continue their work formally as part of the Expedition 71/72 crew through February 2025. They will fly home aboard a Dragon spacecraft with two other crew members assigned to the agency's SpaceX Crew-9 mission. Starliner is expected to depart from the space station and make a safe, controlled autonomous re-entry and landing in early September.

NASA and Boeing identified helium leaks and experienced issues with the spacecraft reaction control thrusters on <u>June 6</u> as Starliner approached the space station. Since then, engineering teams have completed a <u>significant amount of work</u>, including reviewing a collection of data, conducting flight and ground testing, hosting independent reviews with agency propulsion experts, and developing various return contingency plans. The uncertainty and lack of expert concurrence does not meet the agency's safety and performance requirements for human spaceflight, thus prompting NASA leadership to move the astronauts to the Crew-9 mission.

"Decisions like this are never easy, but I want to commend our NASA and Boeing teams for their thorough analysis, transparent discussions, and focus on safety during the Crew Flight Test," said Ken Bowersox, associate administrator for NASA's Space Operations Mission Directorate. "We've learned a lot about the spacecraft during its journey to the station and its docked operations. We also will continue to gather more data about Starliner during the uncrewed return and improve the system for future flights to the space station."

Starliner is designed to operate autonomously and previously completed two uncrewed flights. NASA and Boeing will work together to adjust end-of-mission planning and Starliner's systems to set up for the uncrewed return in the coming weeks. Starliner must return to Earth before the Crew-9 mission launches to ensure a docking port is available on station.

"Starliner is a very capable spacecraft and, ultimately, this comes down to needing a higher level of certainty to perform a crewed return," said Steve Stich, manager of NASA's Commercial Crew Program. "The NASA and Boeing teams have completed a tremendous amount of testing and analysis, and this flight test is providing critical information on Starliner's performance in space. Our efforts will help prepare for the uncrewed return and will greatly benefit future corrective actions for the spacecraft."

NASA's Commercial Crew Program requires spacecraft fly a crewed test flight to prove the system is ready for regular flights to and from the space station. Following Starliner's return, the agency will review all mission-related data to inform what additional actions are required to meet NASA's certification requirements.

The agency's SpaceX Crew-9 mission, <u>originally slated with four crew members</u>, will launch no earlier than Tuesday, Sept. 24. The agency will share more information about the Crew-9 complement when details are finalized.

NASA and SpaceX currently are working several items before launch, including reconfiguring seats on the Crew-9 Dragon, and adjusting the manifest to carry additional cargo, personal effects, and Dragon-specific spacesuits for Wilmore and Williams. In addition, NASA and SpaceX now will use new facilities at Space Launch Complex-40 at Cape Canaveral Space Force Station in Florida to launch Crew-9, which provides increased operational flexibility around NASA's planned Europa Clipper launch.

The Crew-9 mission will be the ninth rotational mission to the space station under NASA's Commercial Crew Program, which works with the American aerospace industry to meet the goal of safe, reliable, and cost-effective transportation to and from the orbital outpost on American-made rockets and spacecraft launching from American soil.

For more than two decades, people have lived and worked continuously aboard the International Space Station, advancing scientific knowledge and demonstrating new technologies, making research breakthroughs not possible on Earth. The station is a critical testbed for NASA to understand and overcome the challenges of long-duration spaceflight and to expand commercial opportunities in low Earth orbit. As commercial companies focus on providing human space transportation services and destinations as part of a robust <u>low Earth orbit economy</u>, NASA's Artemis campaign is underway at the Moon where the agency is preparing for future human exploration of Mars.

#### **ARRL Urges Protecting the Amateur Radio 902-928 MHz Band**





The Federal Communications Commission (FCC) accepted for public comment a <u>Petition for Rulemaking filed by NextNav Inc.</u>, a licensee in the 900-MHz Location and Monitoring Service (LMS), to completely reconfigure the 902-928 MHz band and replace the LMS with high-powered 5G cellular and related location services.

The FCC <u>Notice requested comment</u> on the effects that NextNav's proposals would have on amateur radio operations in the band. <u>ARRL®</u> is preparing comments urging protection of existing and future amateur uses in this band and urges all amateurs to file their own comments describing their activities in this band and the expected effect of the proposed changes. <u>Click</u> here for a guide to filing comments.

NextNav currently holds licenses in the 900-MHz band that authorize it to provide services limited to determining the location and status of mobile radio units. NextNav ties its request to provide high-power broadband, cellular and location services to the vulnerabilities of the current satellite-based GPS system and argues that implementation of its proposal would complement GPS by providing an alternative nationwide terrestrial location system in addition to cellular and broadband services. Under its proposal, NextNav would be designated the sole nationwide licensee for this spectrum in exchange for its more limited licenses.

The new nationwide license would authorize NextNav to provide much higher-powered traditional broadband and 5G cellular services as well as the related location service occupying 15 of the total 26 megahertz available in the band. The reconfiguration proposed by NextNav would create a 5-megahertz-wide uplink subband at 902-907 MHz paired with a 10-megahertz downlink subband at 918-928 MHz. The 5-megahertz uplink subband would be limited to use by mobiles with a maximum of 3 watts ERP. On the 10-megahertz downlink subband, up to 2000 watts ERP would be permitted in rural areas and 1000 watts ERP in urban and suburban areas, radiating from tower structures that could reach 1000 or more feet above average terrain. These configurations reflect the FCC's rules for standard cellular configurations that have been adopted to govern a number of other bands used for similar 5G and like services.

Although uses by the Amateur Radio Service in this band are secondary to LMS, NextNav is proposing substantial technical and use changes that would completely alter the foundation upon which the current rules and spectrum sharing arrangements rely and undercut shared use of the band by amateurs as well as a variety of other users. In addition, NextNav proposes deletion of a specific interference provision in the Commission's rules that was adopted to encourage and protect continued sharing with amateurs and other secondary users.

NextNav, in its petition, argues without evidence that the changes that it proposes to the 902-928 MHz band "will not impede amateur operations." In an <u>8-page description</u> of NextNav's proposal released by the FCC's Wireless Telecommunications Bureau, the FCC staff asks a series of questions that would clarify the proposal and help the Commission ascertain the likely effect of the proposed changes on existing users if the requested changes were adopted. Comment was specifically requested on the extent of amateur operations in the band, the potential impact of the proposed changes, any other spectrum options that may exist, and the costs for relocations if other options exist.

ARRL is preparing comments urging protection of existing and future amateur uses in this band. ARRL urges all amateurs to study the proposal and file their own comments describing their activities in this band and the expected effect of the proposed changes. The filing deadline is September 5, 2024. Replies to comments are due by September 20, 2024. Click here for a guide to filing comments.

- Option 2: Free Student Membership. This no-cost, Associate membership option is available to full-time students aged 21 years or younger. Applicant must be a resident of the US, its possessions, or Puerto Rico. Free Student Membership excludes access to the ARRL E-mail Forwarding Service, and Associate members may not vote in ARRL elections. Other restrictions and exclusions may apply.

It is now an FCC requirement to have an FCC FRN; active email address and active phone number before taking any exam. Please bring your FCC FRN, original license, a copy of your license (if a licensed ham), a valid photo ID and \$15.00 - Cash preferred.

Effective April 19, 2022, the FCC will charge a \$35.00 application fee for amateur radio licenses. The fee will apply to new, renewal, rule waiver, and modification applications that request a new vanity call sign. License upgrades will not have a fee applied. The fee will be per application. *VE's will not collect the fees at exam sessions*.

<u>AE8FP Amateur Radio Test Team</u> administers ARRL-VEC testing in the Central Ohio area. Our test dates for 2024 are as follows: Januray 20, April 27, July 20, and October 19. #### The Lake County Amateur Radio Association

The Lake County Amateur Radio Association is holding its **2024** Amateur Radio license exams at the **Kirtland Library**, 9267 Chillicothe Road, on the following dates:

This bi-monthly schedule is the first Saturday of every even-numbered month (e.g., February being the second month, etc.). They are held at the Kirtland Library, 9267 Chillicothe Road. It is 1.7 miles south of I-90 on Route 306 (Chillicothe Rd). The library is on the left, just beyond the Marathon gas station. The tests will start at **12 noon.** Please arrive a few minutes earlier.

To register, you will need a NCVEC 605 Form, which will be available at the test. If you would like to complete one ahead of time, be sure it is the Sept 2017 version or later. You can find it by Googling "NCVEC quick-form 605" and clicking on the url for a pdf of the form. Please note **the FCC requires you to provide a FRN** (FCC Registration Number). Social Security Numbers

are no longer accepted. If you are new to ham radio and don't have a FRN, Google "New FRN" and follow the fcc.gov link.

If you are currently licensed, be sure to **bring a copy of your license to the exam.** The cost of the exam itself is \$15.00, and if you wish to pay by check, it should be made out to the ARRL/VEC. Identification with your picture is also necessary, such as a driver's license. If you have any questions, please contact Scott Farnham, KO8O, at (440) 256-0320, or scottfarnham@roadrunner.com

**In addition** to the \$15 test fee, the FCC now charges \$35 to add you to the Amateur Radio database. The FCC will e-mail successful candidates instructions for payment directly to them. Payment must be made within 10 days of the e-mail. This charge does not apply to upgrades.



The following update is from the ARRL website, updated 08/22/2024.

Work is continuing to return the DXCC systems to service. DXCC award processing, including the "Online DXCC" application system, is unavailable at this time. While all DXCC user data is secure and unaffected, we have taken the precautionary measure of keeping the service offline until we can ensure the security and integrity of our networks.

As previously reported, Worked All States (WAS) applications are being processed. WAS certificates and endorsement stickers are being mailed.

VUCC applications are being processed, and VUCC certificates and endorsement stickers are being mailed.

Thank you for your continued patience and understanding.

Preparing for CW Worldwide DX Contest, CW, ZL3IO, Holger, updates us on plans at the **Chatham Islands**, **ZL7DX** station. He is shipping material and supplies" from Napier to the Chatham Islands in mid-September. He has confirmed flights to ZL7 for October 15-31. That trip will be for "maintenance of the existing antennas" and "preparation for the lattice towers." They plan to "pour concrete foundations for lattice towers and guy wires." The plan is to move the existing antennas higher for the CQ Worldwide DX Contest, CW, in late November. A top band antenna is "also on the agenda."

Holger is planning a likely low power effort in the CQ Worldwide DX Contest, SSB, operating with his own call, ZL7IO. Holger's daughter ZL4YL, Xenia, will join him for a week around the time of the CQ Worldwide DX Contest, CW. She will be QRV as ZL7YL. That will be their callsign during the contest, maybe SOAB or multi-single effort. Holger would prefer a multi-two effort; however, even if they ran low power. they would "run out of power within 10 hours". The site is powered by a 10-kWh battery and solar power. While Holger is there in October, he will see if he can secure a generator.

**E51EME** in the **South Cook Islands** is QRV on 6M through September 15. This is grid BGØ8cw. ZL1RS, Bob, will use an ICOM IC-705 to a homebrew kilowatt 6M amplifier into a pair of five-element Yagis stacked on a new, homebrew 11-meter tilt-over mast.

Following this operation, Bob will upload his log to LoTW. Paper QSLs will be available in October through Club Log. Donate to this effort via PayPal.

W5ZN suggests being alert in the afternoon on 6M for E51EME, on 50313 FT8. This one has been heard in the US "south" recently. E51EME is also sometimes on 10M in his afternoons, and he is on the island for "a couple weeks of vacation." At home in New Zealand, he is ZL1RS. On 6M this time he has a pair of 5 element 6M Yagis, stacked, and a kilowatt output, and a QTH overlooking the ocean. Also, in the middle of the night in the US, E51EME has had a good EME signal, at his local moonrise and moonset.

W8GEX, Joe, worked E51EME from Southwestern Ohio.

**E51WLG** in the **South Cook Islands** will also be activated by N2WLG, Tom. He plans to be on Rarotonga, South Cook Islands September 1-8, CW and digital on 40-10. QSL to his home QTH or use Logbook of the World.

TA1HZ, Tev, is heading to **Jersey Island** where he will be QRV as **MJ/TA1HZ** from September 11 to 16, including participation in the Worked All Europe (WAE) SSB Contest. He'll have an FT-891 and a long wire antenna. QSL via LoTW, Club Log, QRZ and eQSL. You can also QSL direct to his Call Book Address (CBA) with 5 US\$ and SAE.

In celebration of the 61st anniversary of Sabah Day special call **9M61S** is QRV until September 16. Sabah Day is the celebration of the Independence of Sabah, East Malaysia, which is on August 31.

The **C5T** and **C5I** callsigns have come through for the late November Dxpedition to the **Gambia** by a group of European hams. They plan to operate from the mainland November 25-29, with a possible trip to the Bijol Islands, IOTA AF-060, when they will switch to the C5I callsign. They plan 60-6M and various modes. QSL to EA5GL and they will upload to LoTW even while they're still in C5.

**ZD7W** is planned for October and November trip to **St. Helena Island** by W6NV, Oliver. He will get a station set up to do the CQWW SSB and CW weekends. He is planning the unassisted category.

OZ1DJJ, Bo should be QRV from Greenland until September 12, from **West Greenland**, where he will operate from various locations. He says, "Don't expect too much of me," it is not a DXpedition. QSL via OZ0J.

GOVDE, Bill, is traveling to **Pitcairn Island** where he plans to be active as **VP6WR** from September 5-15. But first he will be heading to Tahiti on August 31, where he will be staying for a few days then on to Mangareva Island on September 3. He'll return to Mangareva on September 17 and will be QRV as FO/GOVDE until September 21. He then goes back to Tahiti and will fly back home on September 24.

N5DD, Don; KC5DJI, Amy; K5PI, Robert; VE7KW, Keith; and W5MJ, Madison; are heading to Pago Pago, **American Samoa**, early next month. They will be QRV as **KH8T** from September 2-16. Plans are to give "as many of the Deserving as possible a chance to work an All Time New One, or a new band or mode country. They will be QRV on 1.8 through 50 MHz on CW, SSB, FT8 and FT4. IZ8PWN, Michele, is planning a honeymoon "holiday style DX Pedition" to the Thudufushi Island Resort in the **Maldives, 8Q,** from September 6-13. He will be on SSB and possibly FT8 on 40, 20, 17, 15, 12 and 10 meters. Michele will be running 100 watts into a multi-band dipole. QSL via I8KHC.

VA3QR, Phil, is back in **Panama** and QRV as **HP3/VA3QR** as he awaits his new Panamanian callsign. Listen for him on 40 through 10 meters and 6 meters.

The **6O3T** DXpedition team, who are going to northwestern **Somalia** in September have announced they will not be using SuperFox but rather going with MSHV instead. "Having carefully weighed up the pros and cons of using

SuperFox mode, while recognizing that if developed, it could become a high standard, at the moment we feel it is still too young."

# CORNER

Below is a list of upcoming contests in the "Contest Corner". I think this is important for someone who is trying to move up the DXCC ladder since entities that are on the rarer side and easiest to work in contests. Some of my best "catches" have been on the Sunday afternoon of a contest when the rarer entities are begging for QSOs. Of course, the gamble is that if you wait until Sunday, conditions may change, or they simply won't be workable. However, it is not a bad gamble. Of course,

why not work the contest and have some fun!

The first contest to mention this week is the CWOPs CWOPEN. CWops sponsors the CWops Test, or CWT, which are fun, weekly competitions at times thought to be optimum for amateurs in ITU Regions 1, 2, and 3.

The CW OPEN (CWO), which is held on the first Saturday in September, is guided by the same principles along with enhancements to make it a serious, annual competitive event.

The Object is to work as many CW stations worldwide as possible within each session. There are three separate competitions at three separate times — each

is called a "session." Each station may be worked once per band in each session. Entry can be made to any or all of the sessions. Each session is scored separately. Entry into multiple sessions will be added together for a combined score in a separate, additional aspect to this event.

The three sessions are Sept 7<sup>th</sup> from 0Z to 0359Z, 1200Z to 1559Z, and 2000Z to 2359Z. More information can be found at the CWOPS website, cwps.org.

The second contest event is the All Asian DX Contest – Phone. The SSB portion is held Sept 7<sup>th</sup> through the 8<sup>th</sup> for 48 hours. The standard HF bands will be used, 10M through 160M. The exchange is slightly different as it is the signal report and your age. More information can be gotten from the WA7BNM website.

With Labor Day just around the corner it means the annual Ohio State Parks on the Air operating event/contest is at hand. The event is aways the first Saturday following Labor Day. Thus this year it will be on September 7 from 10 AM until 6 PM at a state park near you. Speaking of license tests, if you know of someone interested in testing, don't forget to check the Section Journal's listing of monthy scheduled test sessions. Here in Southern Ohio you will find such testing by the **Portsmouth RC** and **Milford ARC** each month. Many of the other clubs give tests too, but on a more infrequent basis. In the meantime, contact your local club and they should be able to point you in a direction to find a testing site that will accommodate your schedule. The **Athens County ARA** will have their next test session at 7 PM on October 21 at the Athens Red Cross Building. Another place to test is usually at a hamfest. #### Print an Official or Unofficial Copy of Your Amateur Radio License

As of February 17, 2015, the **FCC no longer routinely issues paper license documents** to Amateur Radio applicants and licensees. The Commission has maintained for some time now that the official Amateur Radio license authorization is the electronic record that exists in its Universal Licensing System (ULS). The FCC will continue to provide paper license documents to all licensees who notify the Commission that they prefer to receive one.

Licensees also will be able to print out an official authorization — as well as an unofficial "reference copy" — from the ULS License Manager. I've created a set of instructions on how you can request an "official" printed copy of your license\*
