SWODXA Announces the DX Mentor Recognition Program

The Southwest Ohio DX Association (SWODXA) in conjunction with ICOM® America, Inc. is announcing a program to recognize and reward amateur radio operators who have played a key role in helping other amateur radio operators achieve DXCC. The purpose of this program is not to bring recognition to those that achieve DXCC but rather to recognize those amateurs that assist others in achieving their first 100 confirmed entities. There is an application form and a judging committee staffed by SWODXA representatives and a representative from both the NCDXF and INDEXA. Those amateurs receiving the mentoring must be under 30 years of age during the calendar year for the award. The intent of targeting this audience is to attract and retain those amateurs that are most likely to remain engaged in the hobby after achieving DXCC. SWODXA is uniquely positioned to bestow this award at the annual SWODXA DX Dinner®. The DX Dinner, held annually in conjunction with the Dayton Hamvention®, is arguably the largest gathering of active DXers in the world. We present the DXpedition of the Year Award®, the DXpeditioner of the Year Award, when applicable, and host the DX Forum there. CQ Magazine announces their CQ DX Hall of Fame inductees at the DX dinner as well. As a technology leader in our hobby, there is no better partner to promote and celebrate this award than ICOM. Ray, N9JA, has been a constant promoter of ham radio, even coining the phrase "For the Love of Ham Radio". CLUBS

Over the next week, almost every club in the OHIO Section will be welcoming their new officers to begin their tenure as club leaders! I want to say "Thank You" to all of those who have served in your club's leadership and management over the past years, and I want to also Thank those who are stepping into those positions. In the history of Amateur Radio, I believe we are now in

an era where the local club is the most important unit in our path to the future, and in fact, to our survival! It's important to remember that we are not in competition with each other, we need to work together, understanding that sometimes our differences complement each other and make us all stronger together.

Last week I mentioned how important it is to keep your clubs info up to date with ARRL. I've since been involved in a little test of that. The first week of January I sent out over 100 emails to Ohio Amateur Radio Clubs, as listed on the ARRL website. I got over 30 *bounces*, and that doesn't include any that might have been delivered to someone who is no longer involved with a club! PLEASE – make sure your club info is up to date! And this goes for social media too! Any place you have an internet presence needs to be kept current. (I know, I'm guilty too.) If someone is looking for information on our hobby, let's make sure they can easily find it and trust it to be correct and current.

As you already know, when the ARRL site got hacked, it took down the Section Managers (and also the Division Directors) bulk email to members capabilities. I have a couple of "stand-alone" lists that I use to get the Section newsletters out, but they're pretty limited, so I'm relying on you to share the announcements each week with your local clubs and other friends. Usually, it's available on the Ohio Section website by Monday of each week, and I really appreciate all of you who help me get it distributed. Thank you. I also want to assure you that that functionality is in the que to be restored. There were some concerns expressed last week that ARRL did *NOT* plan on returning that functionality to the Section Managers.

Following is some of the information I've received from ARRL:

Dear Section Managers,

The truth is that our bulk email tool was one of the services that had been disrupted following the cyber-attack in May. It is a highly integrated tool used for various services throughout the organization, including e-newsletters, membership notices, and the website integration that Directors and Section Managers use to email members in their respective regions.

We have not yet recovered the tool for use in the current systems environment we have been rebuilding since the attack. We have, however, migrated many of the newsletters to a new email platform, like the ARRL Letter which only missed a single weekly issue after the attack.

In the months after the attack, we developed a manual process to support the 15 Directors with email to their Divisions. To help SMs reach members in their Sections, many of the Directors have developed a practice of inviting SMs to forward monthly

reports and news to them, which they have included with their Division emailing's – sometimes as a monthly newsletter, or more regularly if necessary.

This solution is only a close gap as we continue to address the few remaining services that have required additional attention to bring back online, like the most recent resumption of DXCC application processing and returning the system to normal processing times. As with all the other systems we've restored, we need to perform an exhaustive evaluation of each system to ensure that the solution going forward is secure, scalable, and is implemented according to present day 'best practices.'

It is simply untrue that we are making an effort to keep SMs from communicating with ARRL members in their Sections.

I will keep you posted on further developments involving bulk email to Sections, but I can assure you that the commitment to recovering this function has never fallen off of our radar.

Finally, there is also some patently false information circulating about ARRL VEC and our support of ARRL Volunteer Examiners. One such claim is that ARRL has lost the email addresses of Volunteer Examiners. This is false.

As always, if you have a concern about something you read online...please reach out to me. I'm happy to help you, or to set the record straight.

Dear ARRL Volunteer Examiner,

We want to take a moment to **THANK YOU**, our Volunteer Examiners (VEs) for being an essential part of the ARRL VEC program this past year. The number of new licenses issued by the FCC in 2024 was strong, increasing by 23% compared to 2023, while upgraded license activity rose by 12%. VEs served nearly 25,000 exam applicants using the ExamTools online examination system last year, with 88% of candidates earning a new or upgraded license.

The VEC has worked hard to give the community more choices for conducting exams for Amateur Radio Licensing, ensuring flexibility and accessibility for all. An impressive 55% of all successful FCC license candidates were examined using ExamTools in 2024. The availability of remote video online sessions has made it easier for candidates to take their exams.

Additionally, the ARRL Youth Licensing Grant Program, introduced in April 2022, has continued to positively impact the community. In 2024, more than 900 young people benefited from this program, helping to inspire the next generation of amateur radio enthusiasts.

Yes, our VEs have been busy!

Volunteering is important to our organization and the community, and your contributions truly make a difference. Register Exam Sessions: Please continue to send in your session dates for 2025 using the online interactive <u>ARRL Exam Session Registration Form</u> or via email to <u>vetests@arrl.org</u>. Remember to schedule your yearly listings [specific date(s) and location(s)] with us near the beginning of every year. This ensures we have the most up to date information posted on the <u>ARRL VEC Exam Session Search</u> webpage so potential examinees can find you quickly and easily.

Exam Fees: The 2025 ARRL VEC examination fee remains at \$15, and \$5 for candidates under 18-years of age. Visit the <u>ARRL VEC exam fees</u> webpage for more information.

ARRL Youth Licensing Grant Program: The ARRL Youth Licensing Grant Program went into effect on April 19, 2022. ARRL will cover the one-time \$35 application fee for new license candidates younger than 18-years old for tests administered under the ARRL VEC program. The \$35 FCC application fee will be reimbursed after the ARRL VEC receives the completed reimbursement form and the new license has been issued by the FCC. The reimbursement check will be mailed to the fee payer. Also, candidates younger than 18-years old pay a reduced exam session fee of \$5 to the ARRL VEC VE team at the time of the exam. The \$5 fee is for all candidates under the age of 18 regardless of the exam level taken. Proof of under 18 status is required at the session. ARRL Teachers Institute: Coming to a Town Near You

The <u>ARRL Teachers Institute on Wireless Technology</u> is going mobile in 2025. In addition to the cohorts hosted at ARRL Headquarters in Newington, Connecticut, there will be several sessions around the United States this year. The first, hosted by ARRL model school Staten Island Technical High School in New York City, will be held January 21-24.

The format is being refined this year from five days to four. That change, along with taking the show on the road, is expected to make it easier for educators to attend, according to ARRL Education and Learning Manager Steve Goodgame, K5ATA. "Especially for educators juggling a busy family life, a four-day program near them might be an easier option than a five-day trip to New England." Plans are also being finalized for a session in Kilgore, Texas, in July; and another in the southeastern US.

The programming and support continue to evolve. "We really want to support these TI graduates after they leave, so we have rolled out a Discord server so they can stay in touch with their peers who are also implementing the material they learned here," said Goodgame.

Providing community support and engagement has proven key to the ongoing success from the program. Staten Island Tech High's program is led by <u>Everton Henriques</u>, <u>KD2ZZT</u>, a two-time ARRL TI attendee. Henriques has helped many of his students not only get licensed but also be genuinely engaged in amateur radio. Henriques will help ARRL Education Specialist Wayne Greene, KB4DSF, teach the program.

By developing the network of educators who have benefited from the program and by offering the regional opportunities, Goodgame hopes to receive more applications to attend. TI is free for educators, thanks to funding from donors through the <u>ARRL Education and Technology Fund</u>. There is a \$100 application fee if the educator is accepted.

Goodgame sees a long-term benefit to wrapping genuine fun into this radio-centric curriculum. "Inspiration drives innovation so if we don't inspire young people to innovate and expose them to RF, they're not going to innovate in those fields," he said. "Somebody will, it's just not going to be our kids."

ARRL Teachers Institute on Wireless Technology Now Accepting Applications for 2025 Cohorts



The ARRL Teachers Institute on Wireless Technology (TI) continues to grow. Fresh off a <u>highly successful</u> YouTube telethon that raised more than \$41,000 for the program, some of next year's dates have been announced. Applications are now open.

The program is growing, and educators will have the opportunity to attend sessions around the country. "We love having the teachers here at ARRL Headquarters, but we wanted to bring this program nationwide," said ARRL Education and Learning Manager Steve Goodgame, K5ATA. Dates and details of the regional sessions are still being determined, but the hope is to touch many areas of the United States.

The application process is straightforward. Interested educators can find the web form at www.arrl.org/ti. ARRL covers all the costs of the TI, including travel, but there is a \$100 application fee if the teacher is accepted.

The success generated from the program is demonstrable. "The teachers leave TI with energy and knowledge. They've taken that and built tremendous programs in their schools," said Goodgame. The program isn't necessarily designed to get young people licensed, but rather to get them thinking about radio in their other areas of study. Teachers work amateur radio and radio technology into science, technology, engineering, and mathematics lessons. Amateur radio is presented as a pathway to get hands-on with the concepts, and to use them in the real world.



There are 16 cohorts planned for the 2025 ARRL Teachers Institute on Wireless Technology. "The growth we're seeing in TI is a result of the teachers' experiences with the program, and the donors who enable it," said Goodgame. The TI is funded entirely by donations to the <u>ARRL Education & Technology Fund</u>.

ARRL Student Membership

ARRL Student Membership was established to increase youth participation and long-term involvement in amateur radio. Student members can access ARRL membership benefits including the digital versions of ARRL magazines, and the extensive courses and training materials available through the ARRL Learning Center.

Please note: ARRL requires age verification for all student members. Parental/Guardian consent is required for applicants under 18 years of age. Student memberships are not eligible for add-on printed membership magazine subscriptions. Student membership benefits are subject to otherestrictions and exclusions.

Student Membership options:

- Option 1: Full Student Membership. Dues rate \$30 per year. This low-cost
 membership option is available to US Amateur Radio licensees under the age of 26
 years. Applicant must be a resident of the US, its possessions, or Puerto Rico. A full
 member may vote in ARRL elections for Division Director, Vice Director, and
 Section Manager. Other restrictions and exclusions may apply.
- Option 2: **Free Student Membership.** This no-cost, Associate membership option is available to full-time students aged 21 years or younger. Applicant must be a resident of the US, its possessions, or Puerto Rico. Free Student Membership excludes access to the ARRL E-mail Forwarding Service, and Associate members may not vote in ARRL elections. Other restrictions and exclusions may apply.

Applications are now being accepted for campers interested in attending the 2025 Youth on the Air Camp. 


The current application period is for the fifth camp for young amateur radio operators in North, Central, and South America. For the best chance at being selected, applications should be submitted by 2359Z on January 15, 2025. Campers will be selected by the working group and notified by February 1.

To encourage attendance from across the Americas, allocations for campers are being held open for various areas of North, Central, and South America. If countries do not use their allocation or should someone within an allocation decline acceptance, those positions will be filled from the remaining pool of applicants. As this will be an ongoing process, everyone will not receive notification of acceptance at the same time. Preference will be given to first-time attendees.

Applications will continue to be accepted through May 1 and up to 50 campers will be accepted. The application process is free, but a \$100 USD deposit is required upon acceptance. Should a potential camper be unable to pay the \$100 deposit, they may apply for a scholarship or waiver. Campers are also responsible for their own arrival and departure transportation to the camp location. Travel assistance may also be available, especially for those traveling from outside of the USA and Canada. Travel during camp events is provided.

VE Sessions

The following information is for ALL exam sessions:

It is now an FCC requirement to have an FCC FRN; active email address and active phone number before taking any exam. Please bring your FCC FRN, original license, a copy of your license (if a licensed ham), a valid photo ID and \$15.00 - Cash preferred.

Effective April 19, 2022, the FCC will charge a \$35.00 application fee for amateur radio licenses. The fee will apply to new, renewal, rule waiver, and modification applications that request a new vanity call sign. License upgrades will not have a fee applied. The fee will be per application. *VE's* will not collect the fees at exam sessions.

<u>AE8FP Amateur Radio Test Team</u> administers ARRL-VEC testing in the Central Ohio area. Our test dates for 2025 are as follows: Januray 18, April 12, July 19, and October 18. Time and location for these dates are 10:00am at the Westerville Fire Station #111, 400 W. Main St in Westerville, Ohio. The listed dates are co-sponsored by the Central Ohio Radio Club (CORC).

Pre-Registration is required, and open the 1st of each testing month. All information is available at www.ae8fp.net/



IK7WUL, Antonio, is heading to Africa on a humanitarian mission. He might be able to get on the air toward the end of January. His first stop, January 26-31, will be **XT**, **Burkina Faso**; callsign not yet issued.

His next stop will be February 1-6, he will go to **Ghana**, with the call **9G5IK**. From there, he goes to **Togo**, February 6-14, and will be on the air as **5VØDX**. He will wrap up his trip February 14-23 in **Benin** as **TY2AA**. These dates are a "little fluid."

If Antonio is able to get on the air, it will most likely be on 10M SSB.

Antonio is "looking for sponsors to try to help children less fortunate than ours."

with tuner, 40-10 meters, CW, FT8, FT4 and "perhaps SSB if conditions are good," he says. QSL through LoTW and he says if there is enough interest he will have cards printed too.

Larry says his fingers are crossed all the flights work out, saying "I've heard that they can sometimes be sketchy."

We have an update on the QSL status from the **Siera Leone**, **9L5A**, DXpedition. The following QSL update is from the 9L5A website: "OQRS is open and can now receive your QSL requests for 9L5A. It was planned to do it faster but we had to deal with more than five hundred of requests for corrections which we preferred to process before so that the last log loaded is as correct as possible (thank you F1ULQ for this important job). Please be a little patient to receive your QSL as they are not yet printed. If no major problem is detected, LoTW will be loaded (for everyone) in a few days."

HAPPY NEW YEAR from the snow covered hills of Southern Ohio and Ohio's South 40. Did I say "SNOW?" In 2024 it appeared the most snow in Ohio was in its Northern Counties boardering Lake Erie at places like Conneat and Ashtabula. However an article in the Thursday Cincinnati Enquirer and Columbus Dispatch stated all of the 10 places in Ohio hit hardest by the latest round of snow were in the South 40 Region. They ranged from 11 inches in Cleves, Owensville, Landen Southington and McArthur to 12 inches measured in Mowrystown, Pomeroy and Bainbridge. Print an Official or Unofficial Copy of Your Amateur Radio License

(By Anthony Luscre, K8ZT)As of February 17, 2015, the FCC no longer routinely issues paper license documents to Amateur Radio applicants and licensees. The Commission has maintained for some time now that the official Amateur Radio license authorization is the electronic record that exists in its Universal Licensing System (ULS). The FCC will continue to provide paper license documents to all licensees who notify the Commission that they prefer to receive one. Licensees also will be able to print out an official authorization — as well as an unofficial "reference copy" — from the ULS License Manager. I've created a set of instructions on how you can request an "official" printed copy of your license*
