In Memoriam: Hurricane Watch Network Remembers Its Founder

It is with great sadness that I make the following announcement.

Gerald E. "Gerry" Murphy, Jerry as some knew him, passed away on February 25, 2025. He was a licensed Amateur Radio Operator with the callsign K8YUW. He is also the founder of the Hurricane Watch Net. There is a full write-up in our January 2025 edition of our monthly newsletter "The HWN Report".

Gerry, or Jerry as many knew him by, managed the Net from September 1965 until February 1988. He continued to serve HWN as Assistant Net Manager until he retired from in March 1991.

I first met Gerry, (he always addressed himself as Jerry to me and others) via email back in June of 2013, not long after I became net manager. Over the years, I learned a lot from him. During some of our discussions, I learned exactly how our organization came into being. For many years there were various stories of how HWN came into being. During the summer of 2015, I learned there was an article in the ARRL Storm Spotter Book that contained a story about HWN that was completely different. I told Jerry about this and suggested we take the time to set the



record straight for everyone. Within a week, we composed and posted to our website and submitted to the ARRL the actual the creation of HWN, noting this was approved by the man himself, Jerry Murphy, K8YUW. So, the version in the ARRL Storm Spotter Book should now be correct.

From time to time, Jerry would log into our Chat Room during Net Activations to see how things were going. He once told me that he truly missed being on the air. He said a few years back, a tree in his neighbor's yard fell hitting his house and destroying his tower and beam. He never replaced it.

In 2016, Jerry sent me an old VHS tape of him preparing for Hurricane Hugo in 1998 as well as a couple of local news interviews of him. I converted that tape to digital and it is in the members section of our website. The title is called, "A man named Jerry". I plan to post this video to our YouTube channel very soon.

From time to time, during our Net Activations, Jerry would log into our Private Chat Room, this where we do a lot of coordinating behind the scenes, just to be a part of the action and cheer us on. In 2019, shortly after Hurricane Dorian, Jerry sent the members of HWN the following in an email. HWN Members:

Once again, as happens each and every year, I continue to be amazed, pleased, and gratified, that the minor inconvenience at the time which I experienced in Labor Day weekend of 1965, some 54 years ago, with Hurricane Betsy, would lead to such a marvelous and engaging enterprise as the Hurricane Watch Net!

Radio Amateurs at that time were fully engaged in satisfying PICON, which is defined on Google: PICON stands for public interest, convenience, and necessity. PICON is the standard that the FCC uses to set parameters for its control. It is a basis the FCC uses to decide how to monitor the radio stations, and what they broadcast. PICON was brought into action when the Communications Act of 1934 was passed. I am certain such thinking still guides what we do, in all of our ham radio comings and goings. It will be a very sad day if/when that no longer applies!

I often regret very much the nasty thunderstorm that took out my neighbor's big trees, and my entire antenna system. I was suddenly no longer "radio active." I was also, at that point in time, starting to have health challenges that continue even today. That is no surprise, given that I am 82 now. But I still enjoy some of my earlier activities, many of which through the blessings of the Internet, and now principally by carefully monitoring the activities of the modern Hurricane Watch Net. As I said earlier, I continue to be amazed, pleased, and gratified!

I thank each and every participant! This recent storm has been a marathon, and one for the ages. May God continue to bless you all, and give you the strength and guidance to overcome all difficulties, as you serve the Public Interest, Convenience or Necessity!

In post from the ARRL in their weekly email, "The ARRL Letter" posted March 6, 2025, they including the following.

ARRL Great Lakes Division Director Scott Yonally, N8SY, has known Murphy for decades.

"Murphy was a long-time resident of Lakewood, Ohio, and I've known him for almost as long as I've been a ham. He was always a talented guy with a strong military background that made you feel just like you had enlisted into the Marines," said Yonally. "But, in most cases he was just looking out for you and amateur radio. The Northeast Ohio SKYWARN® program was born directly to the work that he did, and as a testament to the devotion that he gave to it, still shows strongly in that the Northeastern Ohio SKYWARN program is still going on today."

Labor Weekend 2025 will mark the official 60th Anniversary of the HWN. Plans for various celebrations are in place and others in the planning stages. One such celebration will be a Special Event "HWN 60th Anniversary On-Air Celebration" scheduled for June 7th and 8th. Please watch our website, www.hwn.org, for more details. We will endeavor to make these celebrations even more meaningful.

Jerry, thank you for creating this great organization. Your vision, care, and compassion, without a doubt, have helped many before, during, and after these dangerous tropical cyclone events.

Hi everyone, well, we made it; springtime has arrived. With it comes all the fun stuff we've been waiting on, right? But, in the meantime, the snow blower is put away, and the lawn mower will be fired up soon. We have to get those things done before we can have some fun, right?

Out of four weekends in April, I plan to be activating POTA for three of them. One weekend will be spent in the Athens area, where I hope to do a return trip to Broken ARO, and Flint Run. For more information on Flint Run, check out my blog at <u>https://wg8x.net/2023/08/how-to-find-flint-run/</u>. You can bet that I'll be writing about that trip as soon as I get back.

My goal of getting the Kilo award at Wingfoot Lake SP (US-3516), and Wingfoot SWA (US-9518) is coming along. I just passed the halfway point at the state park, then it's on to the wildlife area.



On my most recent trip, I set up the link dipole that I discussed last month. It worked like a charm. I'm planning to make it my go to antenna for this year, as I'm thinking of doing more picnic table portable operations. Not that I have anything against operating from the truck, but I think that it's time to mix things up a bit. I've been thinking that this is my year to get out and start exploring the parks, rather than just their parking lots.

In March, I've done a few out-of-area activations. After the Elyria Hamfest, a stop at Camp Belden (US-9450), and Spencer Lake (US-9502) made for a very scenic ride on the way home. It was a beautiful sunny day, and folks were out enjoying the early taste of spring.

On the way to the Toledo Hamfest, I stopped at a rare WWFF-only site near Toledo. Kitty Todd State Nature Preserve, in Lucas County is owned & managed by <u>The Nature Conservancy</u>. Unfortunately, this type of partnership keeps it from being added to the POTA program. The weather conditions at Kitty Todd were OK, with some wind and rain.

The bands weren't great, but the cast of regulars from Europe and the US managed to get into my log from this All Time New WWFF site. I have to admit that making contacts was a bit more difficult without the help from the POTA spotting network. I made about 11 contacts, and headed to my next stop at Campbell State Nature Preserve for a short activation before heading to my hotel for the evening.

I'm still messing with an unusual issue with the mobile station. It's keeping me from not only making contacts on FT8, but in extreme cases, I've needed to unplug the USB cable going to the rig altogether. With warmer weather coming up, there'll be lots of opportunity for you to get out and have fun in the parks. On April 19th, PCARS will be hosting a POTA Shindig at the Cuyahoga Valley National Park. The weekend of April 19th & 20th will also be POTAs Spring Support Your Parks (SYP) Weekend. So, if you can't come out to Cuyahoga Valley, then maybe head out to



another nearby park, or jump on the air from home, and do some hunting. SYP weekend are held 4 times each year (January, April, July, and October), and result in some pretty awesome on the air activity from Friday evening through Sunday afternoon.

This description hardly does it justice though, since I'm pretty sure a BBQ grill is an integral part of the equation for this event. Tower Light Project And A Fun Fact

We now have a new club decoration. The beacon taken from the Jim Aylward antenna located at the club site has been converted to a decoration and placed in the VHF room. We saved the light from destruction during the removal of the tower in 2024. It took a lot of cleaning and rewiring to make it work, but the project is complete.

The tower and the light were installed in 1954 by ODOT and were used to support ODOT vehicles and emergency services for many local communities. The light was a Crouse Hinds FCB12 universal model designed to be used for aviation and marine navigation. Crouse Hinds produced this model from 1949 until 1981 when Crouse Hinds was sold to Cooper. The light had a clear outer lens and could be equipped with green, red and no filters to create the three most common colors for

navigation. Ours was equipped with two red filters. Later models were made completely from red glass to make them easier to maintain. The light had two 600-700 watt 120 VAC incandescent bulbs. The two bulbs were wired independently. This allowed the current used by each bulb to be measured independently. If a bulb failed a current sensor would show no current flowing and send an alarm indicating, it needed to be replaced. The theory was only one bulb would fail at a time. I know hams like to take things apart to see how they work so I have included a diagram of the light. The diagram does not show the installed filters. A picture of the filter for the upper light is below.

The outer glass is cut to form a Fresnel lens. This lens is used to direct the light from the bulbs in the horizontal direction. The Fresnel lens uses refraction and reflection to make this possible. See the diagram for a better picture of the operation of the lens. An important feature of this lens is that it has a very short focal length and a very wide aperture. This makes a very compact lens possible. The lens of our light is in great condition. It does have a few chips probably the result of gun fire. It is the most common damage to navigation lighting according to the FCC.

Fun Fact

We all know that light is just super high frequency electromagnetic waves like any radio wave. Did you know that Winston Kock of Bell Labs in 1946 experimented with an antenna based on the Fresnel lens? It was designed for 6 GHz and measured 10 by 10 feet. I have included a picture of that antenna. It worked but other antennas that were smaller worked equally well, so the design was abandoned. You can see the Fresnel pattern in the picture.

We are having a plaque made for the light to honor Jim Aylward. It will be installed soon. Next time you are at the club, take a look.

Reusing Old Gas Mask Bags

Surely I'm not the only person who enjoys thrifting at a good military surplus store, right? As I was at the Ohio Military Surplus Store in Deerfield, I saw several old Soviet GP-5 gas mask kits, complete with the mask and a (most likely) asbestos fill cartridge (Photo A) for \$20. I bought one to add to the ever growing surplus collection I have. After parading around the house for a bit, I noticed that I could put 2 HTs on the side pockets, which are normally used for anti eye fog and a decon kit.

After a little effort, I was able to fit my Radioddity GA-5WB and Wouxon UV7D perfectly with the antenna on (Photo B). You might have room if you use a bluetooth mic or have a slimmer HT. If someone was crafty, this would be a decent QRP bag. Although the GP-5 bag is thin and cheap feeling, there are several other kinds of gas mask bags you can find for less than \$15 with better quality and size. 73!

PCARS Ham Radio License Plates Wanted!

Dig out that amateur radio call sign license plate (with your present call sign), clean it up and bring it to be permanently affixed to the wall in the PCARS club station!

We have over 80 PCARS member's ham plates now, **but we can use more**. Don't have ham radio call plates on your vehicle? Well for those of you in Ohio, you can get the plates sent to you by going to any License Bureau office and filling out the special plate registration form. Have a copy of your current FCC license when you apply. The official form to obtain your Ohio Amateur Radio license plates is on the PCARS IO Group site. Then you'll have an old plate to bring in to get hung up as a *permanent* part of



From the Ohio BMV:

<u>General Information</u>: Owners or lessees of motor vehicles who are residents of Ohio and hold an unrevoked and unexpired official amateur radio station license issued by the Federal Communications Commission may apply for these plates. The official call letters will be the license plate numbers.

<u>Registrant Eligibility</u>: Owner must submit a copy of the un-revoked and unexpired official amateur radio license issued by the Federal Communications Commission. (FCC).

<u>Title Requirements</u>: Ohio Certificate of Title issued in the same name as the FCC license, either singly or jointly, or the name on the FCC license is the same name on the lease agreement.

<u>Vehicle Information</u>: These plates may be issued to passenger vehicles, non-commercial trucks, recreational vehicles, house vehicles and non-commercial trailers.

Type of Plates: Plates will be manufactured with the FCC license.

Issuance Information: Amateur Radio plates cannot be issued with system assigned, reserved, or personalized plate formats.

Renewal of plates can be done at your local Deputy Registrar or by mail using their renewal notice. Amateur Radio License Holders must provide a copy of their current unexpired and unrevoked official amateur radio license issued by the Federal Communications Commission (FCC) at the time of <u>any type renewal transaction</u>.

All plates will be mailed directly to the address on your registration card. The deputy will issue your registration card, stickers and provide you with a permit which will allow you to operate your vehicle while your plates are being manufactured. Special license plate applications are available at all Deputy Registrar license agency locations. These plates cost an additional \$10.00 annually plus the normal registration fees. The fee is determined by Ohio Revised Code section 4503.14.

- FCC License Fee \$35 payable after FCC sends you a link. DOES NOT APPLY to upgrades
- 17 years old or younger? VE Fee is \$5 per the ARRL reduced CE fee Youth Program
- · 17 years old or younger? ARRL will reimburse you the \$35 FCC Fee

Okay - Now All the Details:

- If you are sick, have a cough, a high temperature or have been exposed to COVID-19 or other communicable germs, or someone that has been infected please, *do not* come to the club site. *Use of masks is optional*.
- · No food or snacks allowed.
- · Ensure you have the following:
- A picture ID such as a valid Driver's License, State ID, School ID, or US Passport.
- If you are under 16 years of age, a parent or guardian must be able to vouch for you and you need a copy of your birth certificate (you do not have to give us a copy, we just have to see and verify).
- If you are upgrading to General or Extra You MUST bring your original valid amateur radio license and a copy of your valid amateur radio license to turn in with your Form 605.
- Calculators are okay to use (if you need one) as long as the memories are cleared.
- NO cell Phones allowed.

First-Time Exam Applicants <u>MUST</u> Obtain FCC Registration Number <u>BEFORE</u> Taking Exam - All amateur examination applicants are required to provide an FCC Registration Number (FRN) to the Volunteer Examiners (VEs) <u>BEFORE</u> taking an amateur exam. This is necessary due to changes the FCC has made to its licensing system. Applicants will create an FCC username and account, respond to the verification email from FCC, and then register for the FRN. Register on the FCC's Commission Registration System (CORES): <u>https://apps.fcc.gov/cores/</u>



Email Addresses <u>REQUIRED</u> All applications are required to contain an email address for FCC correspondence. Applicants will receive an email direct from the FCC with a link to the official electronic copy of their license whenever a license is issued or changed. ARRL VEC suggests that those without access to email to use the email address of a family member or friend. Licensees will be able to log in to the ULS using their FRN and password to download the latest version of their license at any time. The FCC no longer provides paper license documents via regular mail.

FCC - \$35 Amateur Application Fee - The Federal Communications Commission (FCC) staff has clarified in response to an ARRL request that the new \$35 application fee will not apply to upgrade to an amateur radio licensee's operator class and changes to club station trustees. The new fees will apply only to applications for a new license, renewal, rule waiver, or a new vanity call sign.

VECs and Volunteer Examiner (VE) teams will not collect the \$35 fee at exam sessions. New applicants will pay the \$15 exam session fee to the ARRL VE team as usual.

When the FCC receives the examination information from the VEC, it will email a link with payment instructions to each successful candidate. The candidate will have **10 calendar days**, from the date of the application file number being issued, to pay. After the fee is paid, and the FCC has processed an application, examinees will receive a second email from the FCC with a link to their official license. The link will be good for 30 days.

Youth Licensing Grant Program - The ARRL Youth Licensing Grant Program, in effect since April 19, 2022, will cover the one-time \$35 application fee for **new** amateur radio license candidates **17 years old or younger** for tests administered under the ARRL Volunteer Examiner Coordinator (VEC) program. The \$35 Federal Communications Commission (FCC) application fee will be reimbursed after the ARRL VEC receives the completed reimbursement form and after the new license has been issued. The reimbursement check will be mailed to the fee payer. Also, candidates 17 years old or younger would pay a reduced exam session fee of \$5 to the ARRL VE team at the time of the exam. The \$5 fee is for all candidates 17 years old or younger, regardless of the exam level taken. Proof of under 18 status is required.

Printing Your FCC License

As of February 17, 2015, the **FCC no longer routinely issues paper license documents** to Amateur Radio applicants and licensees. The Commission has maintained for some time now that the official Amateur Radio license authorization is the electronic record that exists in its Universal Licensing System (ULS). The FCC will continue to provide paper license documents to all licensees who notify the Commission that they prefer to receive one.

Licensees also will be able to print out an official authorization — as well as an unofficial "reference copy" — from the ULS License Manager.
