# Mr. Tornado – One man's pursuit to understand the deadliest storms.

The Super Outbreak of 1974 was the most intense tornado outbreak on record, tearing a vicious path of destruction across thirteen states, generating 148 tornadoes from Alabama to Ontario, damaging thousands of homes, and killing more than 300 people. Meteorologist Tetsuya Theodore "Ted" Fujita spent ten months studying the outbreak's aftermath in the most extensive aerial tornado study ever conducted, and through detailed mapping and leaps of scientific imagination, made a series of meteorological breakthroughs.

His discovery of "microbursts," sudden high wind patterns that could cause airplanes to drop from the sky without warning, transformed aviation safety and saved untold numbers of lives. Mr. Tornado is the remarkable story of the man whose groundbreaking work in research and applied science saved thousands of lives and helped Americans prepare for and respond to dangerous weather phenomena. had a laptop with a variety of weather radar images and demonstrated a couple of weather radar products.

The weather radar products are programs or apps that can be run on PCs, tablets, and phones to organize and display weather radar info. All of the info originates from the **National Weather Service (NWS)** and is available for free from their web site. However, from NWS it is often delayed, slow, and not user friendly. The programs, often free or for just a few dollars deliver the imagery faster and allow it to be organized to suit the user.

As an added bonus, there were storms crossing through the LEARA area during the program so we received some live demos. While both Mat and Dave freely admit they are not weather professionals, this sort of info coming from fellow Hams and weather nerds was really interesting and helpful.

For the May Meeting we will have a special presentation of a PBS American Experience documentary, "Mr. Tornado, One Man's Pursuit to Understand the Deadliest Storms". This video chronicles the life of Dr. Tetsuya Theodore "Ted" Fujita and his research into tornadoes leading to the development of the Fujita or F Scale for classifying tornadoes. Later, he discovered microburst storms which were making airplanes mysteriously fall out of the sky.

This video was mentioned and recommended by Mat Nickoson at a previous LEARA meeting. Typically, most DVDs sold to the public include only the right play the video in a residential setting

### Supercell Wx

I wanted to follow up on Matts recent precentation which also covered Weather rader applications and want to bring attention to this following software:

Supercell Wx is a free, open source application to visualize live and archive NEXRAD Level 2 and Level 3 data, and severe weather alerts. It displays continuously updating weather data on top of a responsive map, providing the capability to monitor weather events using reflectivity, velocity, and other products.

For somebody just occasionally wanting to access such radar maps, or not wanting to spend money on the commercial solutions just yet, this might be a good starting point. The software is available here for Windows and Linux:

### ARRL Renews Defense of the 902-928 MHz Amateur Radio Band

ARRL The National Association for Amateur Radio® in a recent filing encouraged the Federal Communications Commission (FCC) to listen to industry stakeholders about the detrimental impacts that changes to the 902-928 MHz band would have for current users.

The FCC is considering a petition by NextNav, Inc., a licensee in the 900-MHz Location and Monitoring Service (LMS), to reconfigure the 902-928 MHz band to obtain more spectrum for itself and replace the LMS with high-power 5G cellular and related positioning, navigation, and timing (PNT) services that would supplement GPS. ARRL filed comments opposing NextNav's proposal in September 2024.

ARRL's latest filing was submitted on May 13, 2025, by the association's Washington Counsel in response to an inquiry initiated by the Commission to consider more broadly ways to improve and harden GPS. ARRL's response echoes concerns of many others and underscores the need to improve and harden the current GPS system in a manner that doesn't impact radio amateurs and other users of the 902-928 MHz

band. The band supports an extraordinary number of unlicensed consumer devices used by consumers both inside and outside the United States with which radio amateurs co-exist.

ARRL strongly agrees with the many parties that point out in the record of this proceeding that, in working with its sister federal agencies on this issue, one of the Commission's primary goals should be to ensure that existing services already operating in the spectrum, such as in the crowded 902-928 MHz band, should not be disrupted by complementary PNT if equal or better means are available. Many billions of unlicensed devices are in use to provide hundreds of applications and functionalities to the American public, and the number of devices and the functionalities that they provide continue to grow.

These devices coexist with amateur radio operations in the 902-928 MHz band but they as well as amateur radio operations would be displaced if a 5G-like PNT service was authorized to use this spectrum.

In the instant proceeding the FCC addresses GPS concerns holistically that also are being addressed by multiple other federal government agencies under the direction of the President. ARRL emphasized the FCC's expertise and role in making the best use of the spectrum resource..
